Discussion took place re: the option of hiring Paula Lantsberger, MD, MPH, FACOEM to facilitate an intrinsic investigative MRI of the Medical Retirement Fire Fighter. The estimated cost of this medical service will be between \$7K and \$10K, will take three or four months, and the expense must be approved by the District Board. For taxpayers of the District due diligence is necessary and per Arizona Revised Statues, this issue must be reviewed five years from the incident. We're four years in, so this would be a proper time to initiate this particular MRI.

Mr. Buddle made a Motion to recommend to the District Board to hire a high-level MRI doctor to facilitate an examination and review of records of the Medical Retirement Fire Fighter and establish whether they are capable of working.

Mr. MacNeal seconded the Motion. All voted yes. **This Motion passed.** 

Mr. Buddle volunteered to take the joint lead on this assignment with Mr. Bourne.

d. The unfunded liability at PSPRS, per the 2022 Actuarial, is \$512,520. Since that time \$300K has been paid towards this liability. Tier 3 Employees are fully fund.
