Mayor Richard stated at the last Regular Town Meeting it was said that a Special Meeting was going to take place to perhaps finalize this topic.

Kenny Boagni stated that the proposed road was abandoned in 2003 and retained a 50' easement to access utilities. Patti Holland stated that Myran's has 25' and the tax office has 25'. Patti stated that she flagged the property and that they are 50' away from the easement. Todd Meche said that the bottom line is that the town does not own the property and land would have to be leased. He feels that the town should not lease anything because the town cannot keep up with what they have. Todd stated that they would have the liability to maintain this dock. Jamie said when the agreement was talked about; the town would have to own the property in order to allow the floating dock. Todd Meche made a motion that the town does not apply for this grant or anyone else apply on behalf of the Town of Arnaudville seconded by Jamie Huval, Roll Call: Annette Bramlett, abstain, Todd Meche, yea, Jamie Huval, yea, Louis Stelly, yea, Suzanne Stelly, no.

Jamie Huval motioned to open the meeting to the public seconded by Suzanne Stelly, unanimously carried.

Mayor Richard asked Patti if the parish could take over this project and perhaps talk to Guy Cormier. Todd Meche stated that if the parish takes over the project the town should not have to sign anything. Willie Wyble said that he wanted to refresh everyone on what was said at a meeting, there was no valid document for the Town of Arnaudville involving the grant people. He was told that he was spreading misleading information, he asked why is it so important to have this document done tonight he said second of all the document that was signed should be between Teche Project and the parish. Willie feels the town should apply for their grant just like pack and paddle; it should also be done for motorized boats as well to make this fair for everyone.

Todd Meche motioned to close the meeting to the public and adjourn seconded by Annette Bramlett and Jamie Huval, unanimously carried.
