- Each entry must be signed by the dog's owner or agent
- Handlers in good standing with AKC are welcome.
- No refunds will be given in the event of cancellation or if the match cannot be completed due to circumstances beyond our control.

- Unsportsmanlike conduct, rudeness to our volunteers, stewards, judges or other exhibitors will not be tolerated and your entry will be voided without refund.
