III. Secretary's Report (Jeanine Stables)

IV. President's Report (John Mannion)

- **a.** Cabinet elections tentatively set for June 14th. Sometime in April, an email will go out to members and let them know people can run. We need a nomination committee to be held at the May meeting date. Anyone who wants to run must be presented at this meeting.
 - Nominating committee will need to be appointed in April Board of ed. elections are quickly approaching. 3 positions are up for elections this year and at least one doesn't plan to run.

Choicesarbitration, but we do have concerns about the rigor of these courses. We may want to consider agreeing to the three course limit for course offered from Augistana. Course must be tied to members teaching or/and strategic planning. Other options available for courses including NYSUT. Also wondering if we can expand the course offerings for the teaching center.
- **d.** SLC- concerns about trying to limit the number for extras before state tests. He feels we try to do that, and that we can seek out principals.
