I then attended the University of North Dakota and graduated with a B.B.A. majoring in Finance in 1991. In 1995, I entered the seminary and studied at Cardinal Muench Seminary in Fargo, ND and it was there that I completed my Pre-Theology work and graduated with a B.S. in Philosophy. I then decided to take time off from seminary and entered the working world this time in the computer software field. I worked for a variety of accounting software companies in North Dakota, Minnesota, and Colorado. In 2004 I decided to re-enter the seminary and four years later graduated from St. Paul Seminary and was ordained to the priesthood on April 26, 2008, for the Archdiocese of St. Paul & Minneapolis. My first assignment was at the Church of the Epiphany in Coon Rapids where I served as Parochial Vicar for two years and my second assignment was at St. Ambrose Church in Woodbury for one year. In 2011 I returned

home to the Diocese of Bismarck and was assigned as Pastor of The Church of St. Joseph in Mandan, ND. On July 6, 2018 I was assigned to be the Pastor of St. Bernard Parish – Belfield, St. Mary's Parish – South Heart and Sts. Peter and Paul Parish–New Hradec.

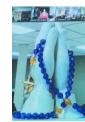

As everyone is getting ready to celebrate summer with family and friends don't forget about Catholic Daughters. Remember to invite people to join, together we are the shining light of Christ in all we do! I just wanted to tell you again how amazing you are each and everyone of you!

FOCUS: In the two year biennium + April of this year a total of \$4911.12 was donated by the local courts of ND. The State Board over this same time period donated \$1970.00 to your state project. So the FOCUS groups of ND received a total amount of \$6881.12 from you the ND Catholic Daughters. This equaled approximately \$2293.71 (give or take a penny) to each of the 3 (three) campuses: UND, NDSU and University of Mary. May we continue to be blessed by the vocations that this ministry is producing on our campuses and in our churches.

Vocations: In March and April we received \$439 from the local courts for vocations. As your State Board we donated \$500 to each of the dioceses. So you as ND Catholic Daughters donated an amount of \$719.50 to each diocese in the support of vocations in ND.

New State Project: Women's Care Centers of North Dakota In March and April we received \$253 from the local courts of ND for the new state project. As your State Board we donated \$500 to the new state project. So you as ND Catholic Daughters donated \$753 to be shared equally by the centers in Bismarck, Devils Lake and Fargo. May we do all we can to support the babies saved in North Dakota over the next 2 years!

The Women’s Care Center (WCC) is a pro-life pregnancy resource center serving women in Fargo, Bismarck, Devils Lake, and the surrounding areas. Their mission is to help pregnant women from our communities choose life for their babies, have healthier pregnancies, become better parents, and take first steps to self-sufficiency. They are a part of a larger network of centers that serves women in 11 different states. Women’s Care Center provides care based on St. Benedict’s theology of radical hospitality. They provide free and confidential pregnancy testing, limited obstetrical ultrasound, options counseling, parenting classes, goals program, community referrals, and material assistance through their store, Crib Club. Last year in North Dakota, they served over 1,000 women.
