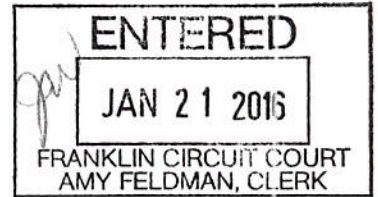



The Deputy Liquidator having consulted the Court about certain issues relating to the operation of Kentucky Health Cooperative, Inc. ("KYHC") and matters relating to healthcare providers, consistent with paragraph 13 of this Court's January 15, 2016 Liquidation Order, and the Court having reviewed the matter and being otherwise sufficiently advised, it is hereby Ordered as follows:

1. No healthcare services provider of any KYHC insured shall balance bill any KYHC insured, except as specifically permitted by that provider's contract with KYHC;
2. For the purposes of this Order, prohibited balance billing means that no healthcare services provider shall bill any KYHC insured for services eligible for payment by KYHC, but not paid in full, nor shall any healthcare services provider bill any KYHC insured for services determined to be ineligible for payment by KYHC, except as specifically set forth in that provider's contract with KYHC.
3. Healthcare service providers shall continue to submit claims to KYHC as has been done in the ordinary course of business. To the extent any healthcare service provider has

other claims against KYHC beyond standard claims for services provided, the provider shall submit a proof of claim prior to the claims bar date of October 15, 2016.


