



Thank you for your interest in the 2018 Havasu Youth Bird Camp sponsored by the Havasu National Wildlife Refuge, Arizona Game and Fish Department, and Friends of the Bill Williams River and Havasu National Wildlife Refuges.

This camp is designed to introduce students in grades 4-6 to the world of birdwatching. The aspiration of this program is to inspire young people and their friends and families to spend more time recreating outdoors, and to foster within them an appreciation for nature that includes birds and all animals, plants, and the habitat in which they live.

The Havasu Youth Bird Camp will take place Friday and Saturday, March 2-3, and will use Topock Elementary School, Topock, AZ, as its home base. Participants will sign in, attend workshops, eat their meals, and sleep at the school.

Camp participants should check in between 2:00 and 3:00 PM, Friday, March 2. Workshops will begin at 3:00 PM and cover such subjects as: common birds of the Havasu National Wildlife Refuge; birding apps; bird identification; how to use a bird field guide, binoculars, and a spotting scope; birding etiquette; raptors of the Southwest.

Saturday morning will be used for birdwatching using the skills and information learned during Friday evening's workshops. Participants will be assigned to a specific team and leader for the morning's nature walks which will take place at North Dike, Pintail Slough, and Catfish Paradise. Upon returning to Topock Elementary School, lunch will be served. A compilation meeting will follow giving the participants an opportunity to share what they observed. The Havasu Youth Bird Camp will end after the compilation meeting.

It is the desire of all who are organizing this event to provide an opportunity for our youth to learn more about the Havasu National Wildlife Refuge and introduce them to the amazing world of birdwatching.

Please send a separate \$40 check, made out to Friends of the BWRHNWR, for each participant. If you need to cancel, you may do so without penalty prior to February 24, 2018. (Checks sent in by those who cancel before February 24, or by those who are not among the first 14 participants to register will be returned to the senders by USPS mail.)
