

# CRUCIFIXION OF JESUS

## PROBABLE MATHEMATICAL PROPERTIES OF THE BLOOD ATONEMENT

The purpose of this illustration is to built upon the work of the late Ron Wyatt and his theory about the place and circumstances surrounding the Crucifixion of Jesus Christ. Specific to the Research or Ron Wyatt, this study suggests that if the stipulations are correct, then the following correlations are probable based on approximate mathematic measurements of distances primarily from the point of the supposed spot of the Crucifixion of Jesus Christ. According to Ron Wyatt's eye-witness account, he dug through to the Cave where the Ark of the Covenant was/is and the other Temple Furnishings were hid-away before the Babylonians came and led Judah to the Captivity or 2nd Diaspora. Astonishing, Wyatt surmised that the Crucifixion Spot was directly upon some 40 feet. Moreover, during the Earthquake recorded in the Gospels, the Rocks rent to create a Crevasse that let the Blood of Jesus flow down to the very Mercy Seat of the Ark. The Jews are looking for a coming Messiah Figure that will allow them to build the 3rd Temple in time of 'Peace'. After the Diaspora in Babylon for 70 Years, it took a Cyrus type of Man to Decree that Jerusalem be rebuilt. This facilitated later on the eventual contrition of the House of YHVH. There was actually a lull in the time that the return of the Exiles started to come back. The Walls were built 1st and eventually the 2nd Temple was then constructed. In the Last Days, will there be a repeat of this Prophetic-Historical Pattern. Since 1948, the Exiles from the Last Diaspora since 70 AD started to return to Israel and the Walls have been built up now. What remains is the construction of the 3rd Temple. Who will be this coming 'Cyrus Anointed' that will facilitated the decree? What could be 1 of the main catalysts do demand such a Temple? It will be after a War. Then 1 such variable and element would be the reveling of the Ark of the Covenant.


This study suggests that the very Crucifixion of Jesus Christ was also fashioned according to Mathematical distances to include a phi ratio factor that correlated approximately to how far the Ark of the Covenant was in approximate distance from the exact Crucifixion Spot. Throughout the Bible, both Old and New Testament there is a clear theological application of how Jesus or the Messiah is a type correlating to the many types and shadows of various elements presented. Most, if not all involve Mathematical Coefficients even.

One such element is the Ark of the Covent. For example in a brief Summation, the contents of the Ark had the Law Tablets, the Bread or Mana and the Staff of Aaron. They all speak of the broken Laws of YHVH that need Blood Atonement or that of a Covering. The Mana or Bread speaks of how Jesus said that He is the Bread of Life. And the Staff of Aaron that budded speaks that Jesus is not only the Branch or coming Messiah Reader but that He would be resurrected.

If the top of the Head of Jesus is the edge and the Feet of Jesus is one factor of the entire measurement, it is speculated based on the supposition of the Garden Tomb that the height of Jesus was about 5'11". What is also a contributing factor is that based on Wyatt's excavations, Jesus was apparently elevated on to a 4 foot Platform as to highlight the spot that was perhaps reserved for the most vile of Offenders and to be clearly seek of the city crowds just outside the Damascus Gate.






Tabernacle of Moses

This study suggests that like the very site of the Crucifixion to the supposed Cave where the Ark of the Covenant was hidden is in phi ratio proportion of distance. If one takes the Height of Jesus to have been 5'11" based on the modification of the Garden Tomb, and then the 4 feet elevated Crucifixion Spot, then one can approximate the distance Mathematically to conclude that indeed the Cave right below the Cross of Calvary where the Lamb of YHVH was sacrificed was approximate 40 Feet below.




Ark of Covenant

What is very unique, as already alluded to was that the place where the Blood of Jesus was purported to have splattered on top of the Mercy Seat of the Ark of the Covenant, paralleled the phi ratio to that of Jesus' Side Wound. This supposition is based on the proportions of the Body that this study suggest are also patterned in the Garden Tomb after the Tabernacle of Moses and the Ark of Noah based on total volume and area.
