Monthly Report for May 2017

This is the monthly report for the Month of May 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Friday, May 5th at approximately 3:14pm officers responded to a school bus versus vehicle property damage only crash on Hwy H are in the area of W. Post Road. The school bus was transporting students from the school to their drop off destinations when the crash occurred. The 32-year-old female school bus driver was issued a citation for inattentive driving.

On Saturday, May 6th at approximately 1:53am officers located a suspicious vehicle parked on the wrong side of the roadway in the 1000 block of Myrtle Road. At the conclusion of the investigation at 17-year-old male was issued a non-traffic citation for possession of drug paraphernalia.

On Friday, May 12th at approximately 9:10pm officers responded to a report of a sinking boat on Pell Lake. At the conclusion of the investigation it was determined that two male subjects had been out on the lake in a canoe when the canoe tipped over causing both occupants to be dumped into the water. A 36-year-old male was transported to an area hospital for unspecified injuries. Both male subjects were issued non-traffic citations for failure to carry personal floatation devices on board.

On Saturday, May 13th at approximately 12:47am officers responded to a report of a single vehicle roll over crash in the area of N1804 Hwy U. At the conclusion of the investigation a 31-year-old male was arrested for operating a motor vehicle while intoxicated 3rd offense. Charges of operating a motor vehicle while intoxicated and operating a motor vehicle while intoxicated with a prohibited alcohol concentration have been forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued a traffic citation for operating left of center.

On Sunday, May 28th at approximately 2:14am officers responded to a report of a single vehicle personal injury crash at the intersection of N. Lakeshore Drive and Clover Road. At the conclusion of the investigation a 28-year-old female was arrested and confined in the Walworth County Jail. Charges of causing injury by intoxicated use of a motor vehicle have been forwarded to the Walworth County District Attorney's office. Two passengers inside the vehicle at the time of the crash were transported to an area hospital for treatment of non-life threatening injuries sustained during the crash.

During the month of May 2017 the Bloomfield Police Department responded to 715 calls for service compared to 1001 calls for service during the month of May 2016. During the month of May 2017 the police department affected 65 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 163 arrests during the month of May 2016.
