Many are also challenged by substance abuse, chemical dependency and/or the effects of fetal alcohol exposure. Your job will be emotionally stressful and, at times, physically dangerous. You will be working with people whose race, sexual orientation, religion, cultural and moral values may be very different from your own. You will be required to treat all people with dignity and respect and you may not impose your personal moral or religious belief on them or the situations they are coping with."

Most jobs require a high school diploma or GED (or the ability to get one within six months of hire). Other academic credentials are welcome but are rarely required. We place a high value on your personal experience and commitment to ending family violence.
