ORDINANCE NUMBER 1994-12

PUTNAM COUNTY RESOLVES AN ORDINANCE ANNEXING BEAGLE CLUB ROAD TO THE TOWN OF CLOVERDALE

An Ordinance annexing portions of Beagle Club Road from the present corporate town limits to its intersection with County Road 450E.

WHEREAS the Town has heretofore on June 13, 1994 enacted Ordinance Number 1994-8, AN ORDINANCE ANNEXING A PORTION OF BEAGLE CLUB ROAD TO THE TOWN OF CLOVERDALE, and;

WHEREAS it is the desire of the Town of Cloverdale to annex Beagle Club Road not heretofore annexed or all those portions of included within previous annexations, and:

BE IT THEREFORE ORDAINED by the Cloverdale Town Board that Ordinance 1994-8 be repealed in its entirety.

BE IT FURTHER ORDAINED that the following described real estate be annexed to the Town of Cloverdale:

Section 1: The following described real estate in Putnam County, Indiana, be annexed to the Town of Cloverdale, to-wit:

TRACT I:

All of that portion of the Beagle Club Road Right-of-Way lying in Sections 25, Township 13 North, Range 4 West, of Putnam County, Indiana.

TRACT II:

All of that portion of the right-of-way of Beagle Club Road lying within Sections 29 and 30 in Township 13 North, Range 3 West, lying West of County Road 450 East.

Section 2: The boundaries of the said Town of Cloverdale are hereby defined to include all of the real estate described in Section 1 above.

Section 3: The real estate described in Section 1 is adjacent to and shall be a part of 2nd District Legislative District.

Section 4: Planned services of a non-capital nature, including police protection, fire protection, road and street maintenance and other noncapital services normally provided within the corporate boundaries, will be provided to the annexed territory effective upon

annexation in a manner equivalent in standard and scope to those non-capital services provided to other areas within the corporate boundaries that have similar topography, patterns of land use and population density.

Section 5: Services of a capital improvement nature will be provided as set out in the fiscal plan adopted by the Town Board. A copy of Resolution 1994-8 setting forth the fiscal plan is incorporated herein by reference.

Section 6: This Ordinance shall be in full force and effect from and after its passage, promulgation and publication as provided by law.
