These terms and conditions are an integral part of this application for the above numbered Appearance Bond for which the Surety Company or its Agent shall receive premium in the amount herein specified, and the parties agree that said appearance bond is conditioned upon full compliance of all said terms and conditions and is a part of said bond and application therefor.

1. The Surety Company, as bail, shall have control and jurisdiction over the principal during the term for which the bond is executed and shall have the right to apprehend, arrest and surrender the principal to the proper officials at any time as provided by law.
2. In the event surrender of principal is made prior to the time set for the principal's appearances, and for reasons other than as enumerated below in paragraph 3, then principal shall be entitled to a refund of the bond premium.
3. It is understood and agreed that the happening of any one of the following events shall constitute a breach of principal's obligation to the Surety Company hereunder, and the Surety Company shall have the right to forthwith apprehend, arrest and surrender principal, and principal shall have no right to any refund of premium whatsoever. Said events which shall constitute a breach of principal's obligations hereunder are:
 - (a) If principal shall depart the jurisdiction of the court without the written consent of the court and the Surety Company or its Agent.
 - (b) If principal shall move from on address to another without notifying the Surety Company or its Agent.
 - (c) If principal shall commit any act which shall constitute reasonable evidence of principal's intention to cause a forfeiture of said bond. This includes a request by an indemnitor or guarantor of the bond to the Surety that the principal be surrendered due to a reasonable belief that said indemnity or guarantor can not ensure the principal's appearance in court.
 - (d) If principal is arrested and incarcerated for any offense other than a minor traffic violation.
 - (e) If principal shall make any material false statements in the application for appearance bond, including the failure to produce agreed upon collateral security for the said bond.
