A copy of your permit will need to be attached to your application.
- ☐ **NON-FOOD BOOTH** – Space only and non-consumable items. 1 table and 2 chairs. Booths selling any kind of spray color, confetti eggs, stink bombs, or any other like items **are prohibited.**
- ☐ **FOOD TRUCKS** - Space only. No electricity, water or additional items will be provided. Copy of Business License is required with proof of food handlers permit.
** A Tooele County Health Department Food Handlers permit will be required. **
- Booth set up will be 8:00a.m to 11:00a.m on Friday the 4th of July
 - You will have until 6:00pm (1 hour after the event) for clean-up.
 - You are responsible for the clean-up of your area and for any damages caused by you or members of your party. Damage fees will be applied if damages occur.

All applications must be turned in by 5:00 pm on Tuesday July 2nd, 2025

Food Vendor's will only be allowed a 10' x 10' space. The space provided for you comes with a canopy 10x10, 1 table & 2 chairs. **NO ADDITIONAL CANOPIES ARE ALLOWED**

Non Food Vendors will receive a space limited to 10x10 canopy, Canopy not included with space.

- If you need to place anything in the ground it must be with approval from Wendover High School Staff or Wendover City Public Works Department.
If you choose to place stakes into the ground and a sprinkler pipe is broken you are fully responsible to pay damages to Tooele County School District.
- You are responsible for the clean-up of your area and for any damages caused by you or members of your party. Damage fees will be applied if damages occur.

Booth hours:

12:00 pm until 5:00 pm on Friday, July 4th, 2025.

- Clean up must be done by 6pm (1 hour after event)

Set Up Times:

- 8:00 am - 11am (Event begins @12) Friday July 4th, 2025
- All booths will need to be set up in advance of event time to pass off inspection. Please be aware these are the only times available for booth set up.
- Vendors must provide their own power source.

Food Handler and Temporary Food Booth Permits:

All food vendors must obtain a food handlers permit & a temporary food booth permit through Tooele County Health Department (435) 277-2300. A copy of your permit will need to be attached to your application. Additional information is required to obtain both of these permits. Any fees paid are directly paid to Tooele County Health Department.
