2023 ANNUAL MEETING RECAP

Thank you to all who took time from their Saturday morning to attend the meeting.

Medvil by-law 5.1 mandates that “one third of the current Membership shall constitute a quorum at a Membership meeting.” Once you account for empty houses, that brings the number of residents needed to meet the quorum at 98; this year we had 100 eligible voters (each home is allotted one vote). If two people had decided not to attend, we would

now be operating on last year’s budget, with last year’s board of directors still in place while putting together another annual meeting in the hopes of getting a quorum. Please think about this next year when you’re deciding whether it’s important for you to attend this meeting.

INFORMATION ON TAXES

Taxes are higher due to the adjustments for increased value of home sales for manufactured homes. The east side calculated at an additional \$33,500 and the west side at \$40,000. The list of sales from 2022 up to 7/2023 was included. For elderly exemption the income limit has increased as well as the amount for assets. If you did not qualify last year you may now qualify. You must resubmit an application annually by April 15. The elderly/disabled exemption must be done by March 1st.

This does not affect the current bill.

Homes that have not been updated may qualify for abatement. Contact the town assessor, Scott Bartlett, at 603-497-8990, Ext. 813. He will need to come to the house to evaluate and the income limit & assets still apply.

There is also a military exemption to inquire about.

LEAVES, LEAVES & MORE LEAVES!

Many are from our oaks which are known for dropping their leaves late into the season (and sometimes well into winter) while some were just left on the ground from last year; whatever the reason, please be sure to get them soon. Not only will they be blowing into your neighbor's yards (which is not very neighborly and very aggravating) but rule D. Sites, item #3 reads in part as follows:

"The maintenance, appearance and cleanup of lot yards are the homeowner's responsibility. Yards are to be kept neat and free of debris and yard tools....Grass clippings and leaves must be placed in biodegradable bags for pick up by park personnel."



Large branches must be placed in a pile at the edge of the road. Shrub trimmings and small branches must be placed in a separate bag with the top left open. It is not permissible to dump your yard waste on Medvil grounds.

The Goffstown Transfer Station requires that yard waste be separated as noted above."

Yard waste pick-up is already in full swing, and you can be sure our Maintenance Team is out there picking them up every Thursday morning. Thank you for your attention to this issue; it's all part of what makes Medvil a beautiful community and great place to live.

RULE REVIEW OF THE MONTH

This new addition to the newsletter will appear monthly as a reminder to our residents of the rules that govern our community.

E. VEHICLES

1) Unregistered and/or uninspected motor vehicles are not allowed in the community and will be towed at the vehicle owner's expense. No vehicle repair or fluid changing is to be performed in the community. Tire changes and minor actions such as adding windshield fluid are permitted.

2) Parking spaces are allocated to each home.

a) Requests for additional parking spaces must be submitted to the Board of Directors, a minimum of two weeks (2) prior to the actual paving. Any additional spaces that are granted must abut existing parking space and must be paved. Gravel or stone parking areas are not allowed. No parking is allowed on lawns.

b) The Board of Directors will not approve requests for changes to driveways between October 1st and April 1st.

c) Only cars, pick-up trucks, vans, motorcycles, jeeps, and golf carts are allowed to be parked in homeowner's driveways, with a three (3) foot setback from the street. The only exception to this rule is that boats on trailers and campers are allowed between May 1st and October 15th (see Rule E.4(d)).

d) Parking on the streets must not interfere with emergency vehicle access or snow removal. No overnight parking is allowed on the streets. No street parking from Nov 15th to April 15th.

e) Paved parking spaces on Constitution Road are reserved for visitor parking and daily use (non-recreational) vehicles of members.

f) All other registered vehicles of members not in regular (daily) use must be parked in the field (unpaved area) on Constitution Road or in the designated storage area across from the office off Donald Drive (as space is available).

TASTY TIDBITS

Looking for something different to go with your holiday meals—a new side dish or dessert? Well look no farther. Here are a few to try for this year that just might become part of your family tradition. Enjoy!

Apple Walnut Slaw

(makes 20 servings)

For the Dressing:

3/4 cup

mayonnaise

3/4 cup buttermilk

4-5 tablespoons

sugar



4-1/2 teaspoons lemon juice
3/4 teaspoon salt
1/4-1/2 teaspoon ground pepper

For the Salad:

6 cups shredded cabbage (about 1/2 head)
1-1/2 cups shredded carrots
1/3 cup finely chopped red onion
1 cup walnuts, toasted and coarsely chopped
3/4 cup raisins
2 medium apples, chopped (your choice of variety)

Directions:

- In a small bowl, whisk together the mayonnaise, buttermilk, sugar, lemon juice, salt and pepper.
- In a separate large bowl, combine the cabbage, carrots, onions, walnuts, and raisins, keeping aside the chopped apples.
- Pour the dressing over the salad and toss.
- Fold the apples into the salad.
- Refrigerate, covered, for at least 30 minutes and up to overnight. Uncover and serve.

Pumpkin Chocolate Chip Oat Bars

(makes 16 servings)

Ingredients:

Nonstick cooking spray
1 cup rolled oats
3/4 cup whole-wheat flour
1-1/2 teaspoons ground cinnamon
1/4 teaspoon ground ginger
1/4 teaspoon ground cloves
1/4 teaspoon fine salt
1/2 cup pumpkin puree
1/3 cup maple syrup
1/4 cup neutral oil (such as canola)
1 large egg, lightly beaten
1 teaspoon vanilla extract
1/2 cup mini chocolate chips
1/2 cup finely chopped walnuts (optional)

Directions:

- Position a rack in the middle of the oven and preheat to 350°. Coat an 8-inch square baking pan with cooking spray and line it with a piece of



parchment paper long enough to have a generous overhang on both sides.

- In a medium bowl, whisk together the oats, flour, cinnamon, ginger, cloves and salt until they are well-combined.
- In a separate large bowl, whisk together the pumpkin puree, maple syrup, oil, egg and vanilla, until they are well-combined. Stir in the oat mixture, then stir in the chocolate chips, and walnuts, if using.
- Spread the mixture into the prepared pan and bake for 25-30 minutes, or until a toothpick inserted in the center comes out clean. Transfer to a wire rack and let cool completely in the pan.
- Use the parchment overhang to transfer the slab to a cutting board and cut into 2-inch squares and serve. Can be stored, covered, at room temperature, for up to 3 days.

Dilly Potato and Egg Salad

(Makes 12 servings)

Ingredients:

4 pounds medium red potatoes (about 14) peeled & halved
5 hard-boiled large eggs
1 cup chopped dill pickles
1 small onion, chopped
1-1/2 cups mayonnaise
1 teaspoon celery seed
1/2 teaspoon salt
1/4 teaspoon ground pepper
Paprika

Directions:

- Place potatoes in a large saucepan; add water to cover. Bring to a boil; reduce heat, then cook, uncovered, until they are tender (about 15-20 minutes). Drain and cool completely.



- Cut potatoes into 3/4-inch cubes and place into a large bowl.
- Chop 4 eggs and slice the remaining egg. Add the chopped eggs, pickles and onion to the potatoes, setting aside the sliced egg.

- In a separate bowl, mix together the mayonnaise, celery seed, salt and ground pepper. Gently stir into the potato mixture.

- Top the salad with the sliced egg and sprinkle with paprika. Refrigerate, covered, for at least 2 hours before serving.



Did you know bubble wrap was originally invented as wallpaper?

If you find popping bubble wrap one of the best things about getting mail, imagine it being plastered all over the walls of your home! Engineer Al Fielding and Swiss inventor Marc Chavannes invented bubble wrap by accident in 1957 while trying to create a textured wallpaper by sealing two shower curtains together to trap air bubbles.



And. . .

...WHO KNEW?

The little black dots on your car's windshield and windows, and the black rims that surround them, aren't just there for decoration. The dots date all the way back to the '50s when car manufacturers used adhesive to hold car windows in place rather than metal trim. The black trim around the windows (called "frits") and the black dots are painted onto the glass to hide the not very appealing look of the adhesive. The rims are actually baked into the window, so they hold the glue and window in place. The dots serve as an aesthetically pleasing transition from the thick black line to the transparent window. They aren't just there to look nice though. They help provide temperature control. When the glass is bent to fit into the frame of the windshield, it's heated up. The black-painted glass heats up faster than the rest, and the dots help to distribute the heat more evenly and keep the glass from warping.

Editor's note: Some bubble wrap doesn't pop when you squeeze it anymore. A few years ago Huffington Post reported that somebody was marketing a bubble wrap with air channels that were made to keep the air just moving from one place to another when you squeeze. I don't recall the stated reason for that. But I think I've received some of that new wrap over the last couple of years, and I'm delighted to relate that if you put it down

FEELING OVERTAXED?

Goffstown's recent property revaluation, which has dramatically increased home values, has many seniors here in Medvil wondering how they'll handle the tax increases coming in 2024.

As mentioned at Tuesday's Board of Directors meeting, there is some potential relief available: partial exemptions for those over 65 if you qualify, and veterans tax credits.

This link <https://goffstown.com/dept/th/town-hall-assessing> takes you to the Goffstown Assessor's page, with lot of links explaining the valuation changes -- basically, that the average sale price of homes in Goffstown has gone up nearly 61% in the last five years.

More importantly, the page also has links to get information on the elderly exemptions and veterans credits and downloadable application forms.

Meeting Minutes

Board Members in attendance: Dorrie Kossuth, Karen Kirkpatrick, Irene Gagne, Kim Capen, Frank Boudreau, Dan Daigle, and Brenda White. Absent were Debbie Cyr and Anita O'Brien.

Meeting called to order by President Dorrie Kossuth at 6:00PM. A quorum was present.

1. Member Comments: A resident asked about whether the new Maintenance employee had a background check done. Kim Capen stated that a background check was done. Another resident spoke about the "Scouting for Food" program. There will be a box in the lobby of DDC where residents can leave items. A resident spoke about residents who don't submit a "Hold Mail" form to the post office. Another resident expressed concern that a potential candidate for the Board will be gone for 2 or 3 months and asked how that might affect the person's involvement with the Board, especially when it comes to written votes. Kim Capen stated that signatures are legal when they are emailed.

2. Treasurer's Report for September 2023: Presented by Irene Gagne: see attached. Everyone will be getting a copy of the financials in the Annual Meeting packet. Kim Capen made a motion, seconded by Karen Kirkpatrick, to contact two banks (Cambridge Savings Bank and Eastern Bank) about a 12-month CD. Motion carried. Following a discussion about the tree program, a motion was made by Irene Gagne, seconded by Brenda White, to approve removing the trees around the septic tanks that need to be removed as well as removing up to 55 of the most dangerous trees for a maximum of \$100,000. Motion carried.

3. Secretary's Report: Karen Kirkpatrick made a motion, seconded by Brenda White, to approve the minutes of the September 19, 2023, Board Meeting. Motion carried.

4. Operations Report: presented by Kim Capen

- There were no email votes for home / shed improvements.
- There were no new requests for home or shed improvements.
- No security issues to report.
- Kim Capen stated that there is a new maintenance person – Jack Lawrence.
