BOARD OF ADJUSTMENT APPOINTMENTS

Discussion

Petty - We had asked for this to be placed back on the agenda after our Board of Adjustment Ordinance went through, got approved.

Stewart - Would you like me to speak on this?

Petty - Sure.

Stewart - So basically our new attorney has told us that we can have the board of Alderman as the Board of adjustment. Right now we are having the attorney clarify, since we do have active applicants if we can still default to the Alderman as the Board of Adjustment or if we have to have a sitting Board of Adjustment. I believe from everything that I've read and from what I've read from the lawyer that we can, as the Board of Alderman, also just be the Board of Adjustment. That way you don't have to deal with appointing everybody and your term is just

your term as the board and that way you don't have a separate board that's overriding another board. It is the people that were elected by the citizens sitting on this board of adjustment that makes rulings on variances and whatnot. So that's the way I would lean doing it, but unless you've gotten further from the lawyer that I missed.

Petty - No, he did give an example of another city. Verbally he gave us multiple cities as example, but in an e-mail, he did share a specific municipality that has served, their Board of Alderman, has served for their as their Board of Adjustments for 20 years.

Hodges - Is it legal not to even have the Board of Adjustments? We've been running for 9 or 10 years without.

Stewart - Basically for 9 or 10 years. It defaults by statute to the board of Alderman being the Board of adjustment unless you have a specific board of adjustment set. So for the last 9 or 10 years, we've just been defaulted to the board or oh our I think Kelly and I are both in the agreement on this that maybe we just continue that default.

Hodges - Do what?

Stewart - Just stay there. Continue to have the Board of Adjustment as the Board of Aldermen. That's kind of, that's where I lean for sure. I don't want to put words in Kelly's mouth, but anytime we've discussed it I think that we agree.

Petty – Yep.

Stewart - And then that way so if any variances come up we can hear them even if we don't have a Board of Adjustment. We are...

Petty - formally appointed.

Stewart - Right.

Hodges - But how would you change your mind as this being the board? Let's say they turn somebody down, the board turns them down. How would they come back again, to the same people again, how's that fair to them? Cause right alongside.

Petty - It would not be the same issues that came to the Board of Alderman that go to the Board of Adjustments. The type of issues that would go to the Board of Adjustments are things that have gone through Planning and Zoning. If a person did not accept the Board of Adjustments final ruling, they can then go to the Circuit Court for further legal action. So it is it isn't the end of the line.

Stewart - And adjustments that we made last time made it so that the Board of Adjustment does just building codes it doesn't cover the whole gamut anymore.

Petty - We narrowed the focus of Board of Adjustments to match..

Stewart - Yes. To what is intended to be.

Petty - ...to match the state statute to only be able to sit for Planning and Zoning book of business basically.

Stewart - And it's not like rezoning stuff, it's hey, I'm going to be 6 inches over what's required on the line. We have to get a variance for that, which we have one of those that were fixing hear before too long.

McMains - Right. Or hey, I want a cow in my backyard for a...

Stewart -Yes, I would like to have a petting zoo in my backyard.

Hodges - I think the board got here would be fair with anybody. That's my opinion. That's the reason I don't feel that we really need to. Because I could be fair with everybody to come here for something.

McMains - You know I'm on board with Mark and Kelly and Franklin.

Davis You need to make that some sort of motion, some sort of an official, something if that's what y'all are doing.

Petty – Okay.

Stewart - Do we want to finish hearing what the attorneys or do we just need to amend our ordinance is what I'm asking.

Petty - To state very clearly that...

Stewart - The Board of Adjustment is the Board of Alderman. Does it need to be written in there?

Petty - Alright, so we're going to get final recommendation from the attorney if we want to include this in ordinance because it is not currently included in what our ordinance states it just defaults by state statute, which if...

Stewart - To do this, we just need consensus of the board, right? To ask something from the attorney which I believe we have. Everyone agrees we should maybe just ask the attorney?

Hodges - Yeah.

McMains - Yep. I agree.

Hodges – Ask him from year to year, when people are being voted off and voted on would we have to be voting them in new? Like I said next April.

McMains – It just automatically goes to it.

Stewart - The question is, do we need to write in the ordinance that that's how we're going to have the Board or Adjustment seated or can we leave it as is and just default to it? Which I think would be a horrible way of doing business because in the future we will just continue to have the same conversation.

Hodges - I just hate that we have to do it is all.

Public Comment Open

Petty - Opening this up for public comment.

Jeffrey McConnell - 5666 UU Rd. When I first heard this Board of Adjustments I'm not familiar with that. It really bothered me to know that unelected board would override our elected officials. That overriding, that was the issue with me so I appreciate you going that route. That's, to me, the most important issue is that we, the people elected you and then another unelected Board just overrides. That's not right. Thank you.

Petty - Alright, public comment is closed. So we have a consensus from the board to reach out to the lawyer for recommendation on updating the ordinance to include that the Board of Alderman will default as the sitting Board of Adjustments.

Petty So 3 meetings ago we said we're going to try out this public comment after each agenda item. we'll try it for three weeks and then we would see how it's going and then discuss how we would like to formalize or and or memorialize this process. So just to start off I like it. I know it kind of lengthens our meetings sometimes, but I think that I believe that it's our job to listen to the people and what they have to say, and they're here and they care. Including them in the conversation is important. The decisions are obviously still ultimately up to the board but I think that having that that avenue to be able to for them to be able to listen and hear the kind of business that we're talking about and share their opinion is valuable not only for engagement but to have an informed board when we are making those decisions.

Cooke - I agree it may have lengthened them a little bit but we've all seen meetings where they've been lengthened for less than stellar reasons, so this is productively lengthening our meetings and I think it's great.

Hodges - Me too.

Stewart - I could see how it could be a problem in the future but I do agree how currently it's not an issue and it's been working out great. Like you know, comments that we just had I think those are good.

McMains – When we hit those hot topics is when it's going to...

Stewart - It might become an issue with that point, but if it does...

McMains - ...Kind of bite us in the butt.

Stewart - ...then we'll readdress it, I guess and.

Petty – So in whatever form we formalize this, there will be guidelines on decorum and expectations for the public comment for the actual members of the public when they're addressing the Board. You know, hostility and or name calling or aggression will not be tolerated and will be shut down so. Do you guys feel like this would best be formalized in the form of an ordinance, in a resolution, in a policy for the City of Fair Grove? How would you guys like to kind of protect that. An ordinance would be stronger. The policy would probably be the well, maybe a resolution would probably be the loosest.

Stewart – I'm personally okay with the resolution for now until we've see you know keep playing it out for a while. And then when we have finally do hit hot topic and see how that plays out and then we can see how we might need to adjust it instead of changing an ordinance we just change the resolution. It's a little less sticky that way.

Petty - So it's good to formalize so that there are clear, like legal boundaries and or expectations around, you know, the freedom of speech and the public then can all be, though everyone will be treated fairly and they have they have clear understanding of what they can bring to us so.

Hodges - How would we handle later on if there is a problem? I know in my mind I think that we should handle with somebody steps out of line. Warn them one time we don't allow this no more We don't want to do it, we're not going to allow it, but if they continue on then we point at that man over there and say remove that person from in here.

Stewart - Currently and you can as you know, correct me if I'm wrong, Chief, but we really don't have anything in our ordinance that has any teeth for him to be able to do anything if somebody is out of line, that's something that we...

Petty - Outside of an immediate threat to...

Chief Riggin - Where you've got to be careful, you've got free speech issues...

Petty - ... or bodily harm.

Riggin - You have no ordinance or anything to say what the decorum is. That's why this is so important, because if you have no process and I remove somebody and they sue you, we will lose.

Hodges – Oh, okay.

Riggin - Guaranteed.

Hodges - Well, what do you feel that we should do in that situation?

Riggin - I'm just here that you decide, but without something with teeth I'm not going to act in an official capacity because that just brings lawsuit to you or liability.

Hodges - So what you're saying is we maybe step this into an ordinance or something later?

Stewart - I think that we should maybe start looking into some surrounding, I've looked in the Springfield because I have quick access to the Springfield's and I know what theirs says but I think we should maybe look at some other small towns and see what they have and see if maybe we can mimic theirs.

Riggin - You guys have one from...

Petty - Chief Riggin shared one with us, when we went to the training, City official training. They had shared a similar much more like it went a whole lot farther than another city and they put in a very strict public comment ordinance.

Stewart – It gives everybody the ability to plan ahead of time, know when they need to be requesting checks and it doesn't give Sara a 'I need this right now'. Sorry. So I'm 100% for signing here and that saves us too, right?

Hodges - I have made this comment on the past this ain't the first board I've been on. Back years ago, I was on the fire department, I was on the board there and the city's most of you haven't been around here so you don't know what went on years ago, but on the city they was doing something that was absolutely wrong and the Mayor, wasn't doing his job. The Police Chief, he wasn't doing his job and his wife was the secretary. The Mayor would sign a bunch of checks and just give them to her. Well she started giving herself and her husband 2 paychecks every

week and the council did so I mean not the council, the person over the money the accountant he never said nothing for a long time, and I said. And he finally said some. Well, the mayor blew up because of him but he wasn't doing his job. He wasn't going and signing the checks, you know, he wasn't doing his job and the Police Chief got fired. She got fired. She got jail time like 6 months. It's been a long time ago.

Petty - Well, luckily there's a lot of things in place that will prevent that from ever happening.

Hodges – Well I ain't saying, but it can happen.

Petty - Mm-hmm.

Hodges - And another thing was when I was on fire board they. Was allowing the police chief, I mean the fire chief to just go spend money and I said I said you can't do this. I said we're representing the taxpayers, I said. They just can't go out to spend money. Well, they wouldn't listen to me. And I came in at the meeting and there was \$6 or \$7000 worth of chemical sitting there on the floor and I already asked them to put a \$500 limit on him because I knew what he was doing. Didn't listen to me, so we had meetings. The police chief he denied it said I'll call the company tomorrow. I said we've got a problem. The police chief said he didn't order this stuff. He said oh yeah he did. I said prove it. He said this is the way they do it. When they call a order in, they've got it on their telephone records. They take it from there down to the shipping department, they call that number back to verify it, and that's how they caught him on it and I said I've got the proof. And I'd like to see us change a little bit maybe on our billing, but we are not paying stuff since we're talking about it. I'd like to see the bills the first night I was on the on the on the fire department they just went through all the tickets and I said no, I said slide them down here and I said first night I said the one with or one with fireman he was making long distance phone calls 70 some odd dollars. Back then, we only had \$17,000 was all we got yea. And I said, we ain't paying this. You know, so a lot of the stuff we're not going to know. Everything we bought you've seen. Something if we physically see it and it don't take that long to slide the bills over. And there's a question we can ask, you know, if there ain't none just sign them then. Then they're just signed. Instead of them not knowing what they're signing for. You know, you know, you know, saying I'm just trying to get for make our so City Council is more better is all I'm asking.

McMains - I plan on getting a stamp for my name and just give it to Sara

Hodges - That'll work.

McMains – I'm just being a smart aleck, no. But I'm definitely for it.

Petty - All right, next up is Committee list. So with Ben Lord off of the Council, we have a vacancy, but I was also putting some thought into kind of the talents and the skills and the special things that the board that we have seated here, what they bring to this Community and what they mean to the community. You know Franklin Hodges, you are a well-respected, well honored member of Fair Grove. You do a lot for those in need in our city including food drives and or helping when you know people need help with their yard work and or tree work. I know you connect people with Chris a lot and on Facebook I see you always offer and reach out for help. I believe that the need is great within Fair Grove. There are a lot of people out there who may or may not have access or knowledge of resources that are available to help them in the form of food or you know utility bills or other things that they need to basically have a peaceful you know, life if they're struggling to provide for their family. This is something that you already do and to be able to put more structure around it and formalize it and give you an outlet and an opportunity to help more individuals I've proposed that we create Community Outreach Committee where this could be something that Franklin Hodges who got voted in because he cares about the people of Fair Grove with all of his heart, this could be a way for you to bring that to the city and to expand it and make it greater than you've had even the ability to do with all that you have already done.

Hodges - Right. I'm gonna tell you this, I thought it ought to be up here with the public relations. You know, and stuff, I thought that ought to be together with them.

Petty - So public relation, OK, go ahead.

Hodges – But I want to stay on the public works sewer and stuff.

Petty - So we no longer, we don't meet monthly anymore. Public works is pretty quiet as far as responsibility of the committee. We meet before the meetings every the business meeting every month for Kenny to kind of give us an update for us to report out on. To give you the space and the ability to focus fully on the community outreach since that is going to take up more of your time I had put you on just the community outreach.

They don't have somebody that's qualified to run their sewer right now I don't know what happened to the person and they suggested like I said, we got a meeting, they got a meeting or class in in October DNR's putting on. We need to find somebody that's willing to go and be a part of that and learn it and be a part of the server department. And so I'm doing my part. I'm doing my job, city Alderman, and like I said I've been on that since we started. I've been on that and I'd like to be on it so.

McMains - I'd like to see him stay on it as well. Here's thing we got Tim Cooke on 4 committees, Mark, on four, you're on 4 Kelly, I'm on three, Franklin's, on one. I'd like to see him be more a part of this and his passion is public works, so I'd like to see him stay on it. And giving him one more committee isn't going to hurt anything. Take Tim off unless Tim wants to stay on it and put Franklin on. So. If we can have somebody passionate about it, like if I'm not passionate about finance committee I'm not going to care that much about it. So if he's passionate about public works he's going to ask the questions that need to be asked and I'd like to see that. I'd like to see if Franklin stay on the Public works committee.

Stewart – Public Works is not me. That's you guys, I got my police committee, guys that I wanted

Petty - So in this committee proposal we've added, I have recommended that we add Ben McMains and Tim Cooke to the Emergency Services Committee and for the Community outreach committee, have Franklin Hodges is the chairman and Ben Mcmains on that committee as well. So this is the committee list that I am presenting to the board. The board has the option to accept and approve this or not.

Cooke - Which committees do you foresee adding additional members to as a full board?

Stewart - Once we fill the seat?

Cooke - Yeah.

Petty - So I was going to put this whoever fills that seat, I was going to have them be on community outreach committee and Public Works Committee.

Davis - You might move in the public comment.

Hodges - Me personally, I want the paper still. I don't care if you guys will want to go to tablets. That's fine. I'll vote for you to have what you want but I still want the paper. This is the reason why. See where I mark everything? I mark my paperwork and there's something I want to discuss, I highlight it. It's here I can go back to it. Computer smart, I'm not and I don't have a tablet. I don't got a home computer now all I got is the phone and this here works out the way I like it.

Cooke - I jotted some notes down on this and Mark and I talked about this at length the other night. I'm not in favor of 100% just saying poof, we're going to e-mail delivery if we're going to do this, I'm fine with digital being the preferred method of distribution, but I believe we also need to leave the option open. If Alderman request printed packets, they are allowed to do so. You don't have to print everyone to packet like you've been doing but if there is a request made, we need to honor that request. As far as going completely digital, we just recently agreed to start putting these agendas outside that door I don't want to back out and reverse on that now. So my question was, why can't this be something where now we're taking two employees man hours plus the benefits you pay them to make photocopies, plus the cost of photocopies, plus the cost of your rent on your copier plus the ink, plus, then I put an officer and say, Brian, go drive around the city for an hour. Because in that variable he's going to start talking to people and my admonition to him was if you get a call when you're delivering packets calls from first. And has that happened yet? Yeah, to be fair, it hasn't happened yet.

McMains - There was no particular order that I did it in. I mean, they set the packets out there when I was on one side well, there you go.

Riggin – I get it and I get like the other day if we were getting ready to deliver packets they made an absconder arrest, they spent the next 7 hours processing a car, processing 2 arrests. That was huge. Packets were not going to get delivered if that were day. I promise you. So it's really what you guys want, but when we were talking about it as employees, when we watched the amount of personnel hours. You know, take an hour of my cops time times two a month, plus hers, plus hers. I only asked the question, could this be done cheaper. What can we do with that money versus this, and that's just me. That's a very personal thing, as in my arena, my officers aren't allowed to make dozens of photocopies. They cannot. They don't need to, and the fact is, if we live in a digital age I require them to understand digital stuff, if not they get wrote up for it because that's a requirement. You have to be digital. So that's just where I'm at. So we will do what we are told to do because we love Fair Grove. We do. That's not a political answer.

Cooke - With that being said, that's where I personally stand on it. Digital by default printed by request, you are responsible for picking up your own packet if you request a print packet.

Stewart – That's a very good middle ground, Tim. I like it. Is there, in making these packets maybe we can play around with how we can streamline that as best possible for Sara. Maybe scanning these in, so it's all one PDF format that you can then just hit print.

Davis - Right.

Stewart - That would be nice to save you an entire day of work to do other things.

Petty - I'm going to open up the floor to our chief of police, who has done a lot of work in investigating opportunities to improve our efficiency with our electricity and with replacement bulbs by replacing our light fixtures.

Chief Riggin - So like any good chief, wanting to save a buck, I was changing light bulbs in our fixture for realizing that the ballast on one is completely gone. The porcelain ends on these old antiques will go out overtime. So as I'm screwing them in they're breaking. So I had a guy come in to put a receptacle in our evidence closet because we have to maintain certain evidence refrigerated. So when he was there, I asked him what it would take to fix those and he said it would cost as much, and he hasn't given me these numbers, but he just threw him out verbally, almost as much to replace the ballast to rewire than it would be to remove it with LED's. LED's are more efficient and you can change the color tones depending on who's in the room and what you want in the room? Second thing is that even if he changed the ballast in the old fixtures he's not guaranteed the ends, the porcelain ends that you screw the old fluorescent tubes in, will survive. So I have one officer sitting under a light that doesn't work. I've had to replace I'm going to say 6, I think it's closer to 8 bulbs. My office has ballasts going out because you can see they're starting to yellow so he said the same thing. You can put a new ballast in, but the ballast plus time him taking it out and rewiring it's going to cost about as much as a new fixture an LED fixture. So I just asked him to give me a bid on all of that. That's happening?

Hokanson - Yeah, got it.

Riggin - Right.

McMains – So what I hear is you're breaking our equipment to get better and newer.

Petty - I would say that he is being incredibly resourceful.

McMains - Here's my question. If, because all these light fixtures are about the same age, because this is all built the same time.

Petty - Mm-hmm.

McMains - Should we look at all my pictures or just limit it to the...

Riggin - You have two out right there and it could be a problem.

Petty - So that was, he actually brought it to me with that same like, hey this is what I would like to do for the Police Department, it might be worth looking into for the whole the whole building for the city. So is that going to be included in the...

Hokanson - No, all he's doing...

Riggin - All I asked for initially was can you get our end? That is the patrol room, my office, the sergeants room is fine right now but with the intention on slowly over time, picking away at it.

Petty - As they go out or a room at a time?

Riggin - Whatever you guys decide, I'm asking, I'm being selfish, I want my end done.

So if we can start with this year, at least that end of the building where I have like when I was taking mug shot pictures We were testing them out on Sara, the lighting was so poor that it was poor it was causing a problem in that hallway where the bathrooms are.

Petty – So yeah. I look forward to seeing those quotes and I think then based off of the information in them, it's probably worth a discussion on if we need to replace them.

Riggin – Right, because this room's not used typically but twice a month, unless you have the library come in during the day when you have sunlight that's different. My officers are closing their shades at night and sometimes during the day for privacy.

McMains – The library is going to be needing it, the hallways going to be needing it. Their offices will need them sooner than, like you said, this room but yeah, if we can go as needed, like police department first and then work our way through.

Riggin – As soon as Kenny's man gets us a bid we'll know.

Stewart – Do we need a motion or what?

McMains - I think we have to wait for the bids to come through.

If you look in QuickBooks where it keeps our account balance plus all the checks that we've wrote that still haven't hit the bank account that it's saying we're -\$72,000.

Hodges - Whoa.

Petty - So this is according to Larry, our treasurer, he said it's common practice for cities to shift the money around because not all of the money just comes in at one time so as the sales tax is collected it replenishes the general fund and then we move the money back into the capital improvements which we talked about last time as having a balance that we do intend to pay back this year.

Stewart - Great.

Hodges - Are we going to get penalized for the \$72,000 from the bank.

Davis - No.

Hodges – They won't penalize us for bouncing checks or whatever?

Petty - Well, we're not gonna let it bounce.

McMains - We're going to move the money over first.

Hodges - So we haven't a bounced the \$72,000 yet?

McMains - No. We have \$11,000 in the bank, right now in that account.

Petty - It is all the all the city's money that's been allocated to separate accounts and and it's just shifting that money to a different account.

McMains - We're taking it all from the sewer and the street department.

Petty - Nope, that's illegal. We can't do that. That's a totally different fund.

Cooke - The difference...

Hokanson - Stop it.

Cooke - The difference as written is \$61,295.56. So what is the number that we are proposing to transfer?

Stewart - I was looking at this thinking transfer 80,000 just to have a little bit of cushion. That's my initial thought. That would give us \$8,000 in the green from what the QuickBooks is, but I'm open to recommendations from the city clerk who has been doing this way, longer than I have.

Davis - I don't really have any recommendations. Payroll is next week and with payroll and taxes and everything that generally is about \$20,000. So, you're going to want enough in there to cover that too.

Hodges - Is this going to be a weekly thing. We're going to be behind?

Davis - No, it's been historically done in July, where I'd have to come, because all of our taxes don't hit it once we're in the middle of the year. We don't have our property taxes to rely on right now, so.

Hodges - So this won't happen again?

Davis - It'll probably happen next July and it might happen in December, I don't know. I can't guarantee any of that.

Hodges - I was going to say whatever the amount is to get us by instead of having to come back and be short.

McMains – So, we're looking at \$100,000 to transfer over to cover payroll and everything else?

Hodges - \$100,000 get it?

Stewart - That's the number that pops in my head with Sara's....

McMains - And give us a buffer.

Stewart – Right.

Stewart - So I'll make a motion unless you...

McMains - Good, go ahead. I'll second it.

Cooke - All yours, buddy.

Stewart - Alright, approve motion to approve city clerk to transfer \$100,000 from Capital Improvement Fund to general fund with the stipulation that it will be paid back within the year.

Hodges - Are you talking about my Social Security? They said they'll put it back in there.

Petty - Thank you.
