- **We will email an invoice** for your cost for each item and shipping, if applicable. Your organization's cost per item is 50% of the retail prices when selling 150 or more items, 40% profit if less than 150 items are sold.
- Pay for your purchase. Payment by school/organization check, money order, cashiers, or certified check is required.
- A confirmation will be emailed to you once we receive payment (school/organization check, cashier's check, or money order. Once payment has been received, your order will be submitted to our shipping department for processing. Orders are shipped by UPS. Large orders may be delivered by Common Carrier. You are welcome to email our office anytime for shipping updates and estimated delivery date(s). Once payment for your order has been received your order will ship in approximately 3 weeks.
- **Report any missing or broken items**. Seldom are there any missing or damaged items with our shipments. However, should any corrections be required, return the check-in form within 48 hours and we will process a new order for the replacements.
