

Buck Brannaman Clinic 2025

Participant Information and Instructions

Each class session is limited to 25 riders. Riders must bring their own horse. If you would like to participate as a rider, you must first contact clinic sponsor Gail Pearles either by email gailpearles@yahoo.com or by phone 716-982-5180. Spots are given on a first come first serve basis. If you get a spot in a class, download the Rider Application Form and submit a non-refundable \$375 deposit to officially register. If your Rider Application and deposit are not submitted within 14 days of your notification, your spot will be given to the next person.

Once a class is FULL, a waitlist will be created. Waitlist application requirement is the same procedure: complete the Rider Application Form and submit a \$375 non-refundable deposit to secure your spot on the wait list. If no spot becomes available, your deposit will of course be returned or destroyed. The only way to reserve a spot is with the deposit.

REGISTRATION PROCESS:

1. Submit Within 2 weeks of Clinic Spot Notification: **\$375.00 Deposit along with your Rider Application Form ONLY. Do not submit any other forms at this time.**
2. Submit by August 15, 2025: Full balance payment along with remaining completed forms which includes: Buck Brannaman Liability Waiver, Stall & Camping Reservation and Coggins Certificate.

Due to the high volume of participants and paperwork, please send all of the required forms at one time along with your full payment by August 15, 2025. With so many participants involved, it is a burden for our volunteers to receive documents randomly throughout the year.

If full payment is not received by August 15, 2025, a waitlist applicant will be given the spot.

PAYMENT: Check or money order are only forms of payment accepted. Once deposit is received, the spot is yours and yours alone. Your spot is not transferable to another person or to the following year, nor can it be used for spectator fees. However, movement between classes may be available. All checks and money orders are made payable to Gail Pearles. Canadian friends: Please make sure that your deposit and balances are in US funds only. When your spot is assigned, you will be notified by email and the \$375 deposit then becomes non refundable and non transferable. The balance will be due by August 15, 2025 —no exceptions.

STABLING: Box Stalls \$20/day. Thursday-Sunday \$80.00 plus one time mandatory clean out fee of \$20.00. Tack Stall \$20/day. If you plan on leaving Monday, add on the additional Box Stall Fee and Tack Stall Fee. Due to NYS fire code: no hay, bedding, saddles, wheel barrows, pitchforks, water buckets etc may be placed in the aisles of the barns.

Stalls are standard portable stalls with full doors. Stall floors are cement. Stall reservation forms must be filled out and returned with full payment by August 15, 2025. If you want to be stabled with a friend, please put their name on one form only and we will do our best to stable you together. Stalls will be available starting on Thursday September 25, 2025 at noon. Bedding will be available for purchase in advance, send in with stabling form. Vendor pricing will be coming in the Spring of 2025. We will have the stable forms updated as soon as we receive pricing. Bedding will be delivered to each prepaid stall. Stalls are located in the Main Showplex and Barn 11. Please lead your horse into the arena and mount once inside. No horses allowed on grass or in camping area. **As per NYS Law, smoking is not permitted in any building at any time.**

HORSE HEALTH DOCUMENTATION FOR NYS HORSES: Negative Coggins test taken within 24 months of clinic date. Current rabies vaccine with one year.
Recommended Vaccines: EIV/EHV 1 & 4, Potomac Horse Fever, West Nile

OUT OF STATE HORSES: Negative Coggins test taken within 12 months of clinic date, rabies vaccination & health certificate dated within 30 days.
Recommended Vaccines: EIV/EHV 1 & 4, Potomac Horse Fever and West Nile

CAMPING: \$50/day. Thursday - Sunday: \$200.00. If you plan on leaving Monday, add an additional \$50. There are plenty of spaces available for campers that require electrical and water hook up. Spots will be on a first come, first serve basis. No camper spots will be reserved. Showers and restrooms on site. Must have camper permit. Once paid and confirmed your permit can be obtained from Designated Event Volunteers and Gail Pearles (located in the Showplex). Please display on camper or trailer. Please note that RV and Camper Awnings are NOT PERMITTED. Concession stand is located in the Showplex

DEADLINE FOR SPECTATOR PRE-PAID CAMPING: September 15, 2025. Permits can be obtained at the Horse Show office (located in Showplex). After September 15, 2025 camping fee is \$60.00/day. There is no dumping station on site. Dogs are allowed in the camping area. **NO DOGS ALLOWED IN THE BARN OR SHOWPLEX.**

FACILITY INFORMATION:

Showplex Ring: 228 feet X 118 feet with sandy loam mix

Warm Up Ring: 62 feet X 228 feet with sandy loam mix

Dressage Ring: Standard size with limestone and sand mix

Directions to the Showplex on the Fairgrounds, Hamburg, New York:

For your Nav—Type in **Erie County Agricultural Society** for proper entrance.

From the EAST: take local roads to 1-90 (NYS thruway) to Exit 56, Blasdell/Milestrip Road. After exiting, at the light, turn left (east) onto Milestrip Road. Travel about 1/2 mile, turn right onto McKinley Parkway. Follow McKinley about 5 miles to the Fairgrounds. Enter the Equestrian Show Grounds at the first gate on your right, just past Quinby Drive.

From the WEST: take local roads to 1-90 (NYS Thruway) to Exit 57 Hamburg/Camp Road. Travel about 1 mile, turn right onto Southwestern Blvd. Continue on Southwestern Blvd. (Route 20) to McKinley Parkway. Turn right onto McKinley Parkway. Follow McKinley about 5 miles to the Fairgrounds. Enter the Equestrian Show Grounds at the first gate on your right, just past Quinby Drive.
