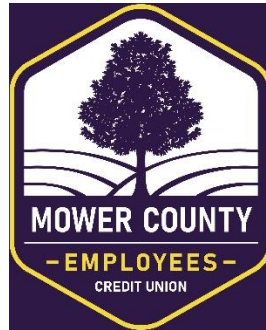

The Mower County Employees Credit Union is happy to again offer the Holiday Skip-A-Payment service as an added benefit for financing your loan with us.

You may be eligible to defer ONE MONTH of regularly scheduled payments for your choice of November 2021 or December 2021! If you wish to participate, please return the enrollment form OR enroll online at www.mowercountycu.org. The payments skipped will extend your loan by one month. Interest will accrue during the skip period. A fee of \$20.00 per loan will be added to the principal of the loan.
