Upon Roll Call, Commissioners Bernie Cosby, Mike Gambill, Bob Grah, Allen Huddleston and Bud Oldani were present via video conference. Commissioner Jerry Rust was absent. After roll call Chairman Huddleston announced that a quorum was present for the transaction of business. Also in attendance was Village Administrator/Clerk, Carla Ayala and Keith Thompson, Innsbrook Corporation.

NEW BUSINESS:

- a. Innsbrook Estates Plat 105; Rubin Ridge Court - Keith Thompson spoke to the Commissioners about Plat 105. Rubin Ridge Court is located off of Alpine Lake Drive, across the road from Lot 2293. The eight lots on this plat will consist of residential chalets, all on the Corporations sewer system. This is consistent for that area. These lots are already zoned Planned Residential District (PRD). There is a minimum thirty foot buffer surrounding the plat. The closest entrance into Innsbrook Resort that would serve these lots is off of Stracks Church Road. The Commissioners showed concern over the sight lines along Alpine Lake Drive, which would be the responsibility of the Homeowners Association. Keith Thompson will speak with Jeff Yegge about this concern. Motioned by Commissioner Gambill, seconded by Commissioner Grah, for the Planning and Zoning Commission to recommend for approval to the Board of Trustees, Innsbrook Estates Plat 105. By roll call vote, Commissioner Cosby - "Aye", Commissioner Gambill - "Aye", Commissioner Grah - "Aye", Commissioner Huddleston - "Aye", Commissioner Oldani - "Aye", Commissioner Rust - Absent. All members present voted "Aye". Motion passed and approved with a 5 "Aye" - 0 "No" vote.


ADJOURNMENT


