## Keeping Yourself and Others Safe At Polling Stations

While we prepare to head to the polls on election day, individuals can take certain preventative measures to protect themselves and others around them in order to stay safe and healthy. We advise individuals to listen closely and comply with the rules and procedures put in place by the election officials as you arrive at your polling station. Routine cleaning and disinfection of polling location areas and associated voting equipment shall be in place. However, in addition to that, the following guidance provides further recommendations for registered voters in our community. Use the restroom prior to leaving your home to avoid the use of onsite facilities. Bring with you, alcohol-based hand sanitizer with at least 60% alcohol, for use before and after using the voting machine, and as the final step in the voting process. You can also bring with you a regular black sharpie marker, if you do not want to share the marking device provided. Wear a face covering to protect yourself and others around you. Don't forget to social distance by preferably staying at least 6 feet apart. If this is not feasible, efforts should be made to stay as far apart as is practical. If possible, do not bring nonessential visitors with you (e.g., children, grandchildren, pets). Voters should refrain from greeting others with physical contact (e.g., handshakes, touching). As always, stay at home if you have a fever, respiratory symptoms, or believe you are sick. Working together we can prevent the spread of COVID-19 in our community.

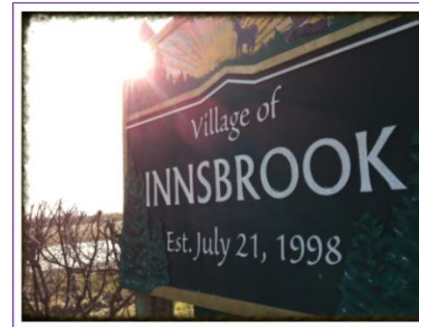
