*-**Early-8's.** As a recap, when a player has an early-8, we simply count the remaining balls they have left on the table and score the match accordingly. For instance, a player accidentally pockets the 8 and has three balls left on the table. We subtract 3 from 7 to arrive at 4. This would result as a 10-4 loss for the player who had the early-8.*

Last week, a question came up on how to score an early-8 if the table is still open? If a player has an early-8 and the table is still open it is a 10-0 loss. Example: A player breaks and pockets two solids on the break. They call their first shot and miss. During that shot they inadvertently knock the 8-ball in. This would result in a 10-0 loss, even though two solids were pocketed on the break. This is because the table has not been established, and the two pocketed balls do not belong to either player.
