**Club Dock Slip Rental policy and regulations for Lake Forest Yacht Club (LFYC) members:**

1. Only members in good standing have the right to rent dock space. **All financial obligations to the club must be paid up to date before dock space will be assigned or slip or launch used.**
2. Only boats registered in the name of active members are eligible for mooring at members' dock rental pricing. **A COPY OF THE CURRENT BOAT REGISTRATION MUST ACCOMPANY THIS RENTAL AGREEMENT.**
3. Boats docked without proper identification may be removed at the discretion of the Dock Master at the owner's expense.
4. The Lake Forest Yacht Club (LFYC) has the right to remove any visibly damaged, sinking or sunk boats at the owner's expense. LFYC will be held harmless for any original damage(s) or additional damage(s) which may occur with the removal of such boat.
5. No winter storage will be permitted. Boats must be removed by December 1<sup>st</sup>, 2019 or the LFYC may remove it at owner's expense.
6. No boats are to be left on LFYC property after removal from water.
7. Carpeting and / or tires will not be permitted on Any docks.
8. LFYC does not guarantee dock renter ability to use the lake waters for boating. Lake water level may raise or lower due to environmental conditions or state regulated water level draw down. Dock Renter agrees to hold LFYC harmless for inability to use the dock slip due to water level conditions and is the responsibility of the dock renter to safely moor, operate or remove their vessel in accordance with water level conditions.

I will abide by all the Club Dock rental regulations as detailed above. I agree to hold the Lake Forest Yacht Club (LFYC) free from any and all liability including injury to person(s) or property and / or loss in connection with the use of the premises. I also agree to reimburse the LFYC for any damage to the premises arising from my use of the premises.
