# Hillsborough COVID-19 State of Local Emergency Extended;Face Coverings Mandate Still in Effect

Hillsborough County has extended its state of local emergency enacted in response to the COVID-19 coronavirus pandemic. The declaration includes a mandate that face coverings must be worn in indoor locations of businesses, with certain exceptions.

Hillsborough County Administrator Bonnie Wise today extended the declaration under authority authorized by the County's Emergency Management Ordinance and the Board of County Commissioners.

The extension is in effect at least through Nov. 5. A state of local emergency can be in effect for only seven days, unless extended. The emergency declaration gives the County Administrator and emergency managers the ability to quickly take certain actions to ensure the health, safety, and welfare of the community, and provides a path for federal reimbursement of certain expenses.

Commissioners will discuss the state of local emergency and other COVID-19 issues at their next regular meeting on Thursday, Nov. 12, at 10:15 a.m.

For more information regarding Hillsborough County's face coverings requirements, go to HCFLGov.net/facecoverings. Residents and visitors are also reminded to practice social distancing, avoid large crowds, and wash hands frequently.

# Things to look for while choosing a quality Pre-school for your little one during COVID Is It Safe to Send My Child Back to Daycare During COVID-19?

Daycares are reopening in states across the country and likely near you. But are they safe as COVID-19 cases still exist? Here's what you need to know about the safety measures pre-schools/daycares should take to protect your child.

Some pre-schools in the U.S. stayed open for the children of essential workers during the entire pandemic, others couldn't survive the financial burden of closing for so long, and now—months after the coronavirus crisis began—the remainder of child care centers are opening their doors to families again. But how safe are they, and should you send your kids?

There's no right or wrong answer, as every family is in a completely unique situation. But if you're on the fence and able to keep your kids at home a little longer, it might not hurt to do so.

Parents should especially consider holding off on sending their kids back to daycare if logistically possible if the child has an underlying medical condition or a previously diagnosed weakened immune system, this is the recommendation of the top medical professionals.

Being a pre-school teacher for 37 years myself, it is very scary for the teacher's as well.

Not every family has the option to stay home, though. Some parents will soon have to return to work in person, some need support after weeks of trying to make ends meet, and for others, the workload is just too much to have a child at home. Other parents are simply ready for their kids to get back into their normal routines and socialize again, and that's OK too. At the end of the day, every parent needs to decide what's best for their family.

Working with guidance from the Centers for Disease Control and Prevention (CDC) and local and state health officials, you can rest assured that daycare owners are taking every precaution to protect your little ones from COVID-19.

#### These are the Safety Measures the Pre-schools/Daycares Should Take to Lower the Risk of COVID-19 Kids should be screened daily.

• Children and staff who are sick or who have tested positive for COVID-19 will be required to stay home. A larger outbreak might require the facility to close for two weeks.

• Pickup and drop-off times will be staggered and done outside of the facility, with one parent or caregiver being designated to come to the center at a given time. Parents must wear a face covering.

• Temperatures of children and staff will be taken and recorded daily, and may be repeated throughout the day; those with 100.4 and over will not be able to enter.

• Parents will also be asked whether or not the child has recently been near someone with COVID-19 or if anyone at home is sick. If the answer is "yes," they will not be able to enter.

#### Social distancing and hand-washing should be enforced.

Staff should be required to wear cloth face masks.

• Hand-washing will be implemented immediately upon entering the center, and frequently throughout the day.

• Social distancing will be reinforced as much as possible, with children split into smaller groups. They will remain with the same caregiver and group all day, which means no communal eating, playing with other classes, or assemblies.

Visitors will be prohibited.

• Outdoor time is suggested as much as possible, but social distancing should continue. Any outdoor toys will be disinfected before the next group comes out to play.

#### Cleaning will be taken up a notch.

• Surfaces and objects that are frequently touched will be even more thoroughly cleaned and sanitized.

Toys will be disinfected between use.

• Sensory play (think water tables or sandboxes), plush toys, and anything that would not easily be cleaned between uses will not be permitted.

• Every child should have their own supplies to limit contact. Shared crayons or scissors, for example, would be harder to clean during an activity.

Proper nutrition, exercise, a good night's sleep, and frequent handwashing are more important than ever to boost your family's immune system.

Setting up a time to talk to the director of the center of your choice is the first step to ensure that they're taking every step necessary to protect your kids. You've got to trust your gut and do what feels right for your family whether that means sending them or keeping them home.

# **History of Veterans Day**

World War I – known at the time as "The Great War" - officially ended when the Treaty of Versailles was signed on June 28, 1919, in the Palace of Versailles outside the town of Versailles, France. However, fighting ceased seven

months earlier when an armistice, or temporary cessation of hostilities, between the Allied nations and Germany went into effect on the eleventh hour of the eleventh day of the eleventh month. For that reason, November 11, 1918, is generally regarded as the end of "the war to end all wars."

In November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice Day with the following words: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations..."

The original concept for the celebration was for a day observed with parades and public meetings and a brief suspension of business beginning at 11:00 a.m.

An Act approved May 13, 1938, made the 11th of November in each year a legal holiday—a day to be dedicated to the cause of world peace and to be thereafter celebrated and known as "Armistice Day." Armistice Day was primarily a veterans of World War I, but in 1954, after World War II had required the greatest mobilization of soldiers, sailors, Marines and airmen in the Nation's history; after American forces had fought aggression in Korea, the 83rd Congress, at the urging of the veterans service organizations, amended the Act of 1938 by striking out the word "Armistice" and inserting in its place the word "Veterans." With the approval of this legislation (Public Law 380) on June 1, 1954, November 11th became a day to honor American veterans of all wars. Later that same year, on October 8th, President Dwight Eisenhower is-D. sued the Veterans Day Proclamation which stated: "In order to insure proper and wideobservance spread of this anniversary, all veterans, all veterans' organizations, and the entire citizenry will wish to join hands in the common purpose. Toward this end, I am designating the Administrator of Veterans' Affairs as Chairman of a Veterans Day National Committee, which shall

day set aside to honor

include such other persons as the Chairman may select, and which will coordinate at the national level necessary planning for the observance. I am also requesting the heads of all departments and agencies of the Executive branch of the Government to assist the National Committee in every way possible."

Veterans Day continues to be observed on November 11, regardless of what day of the week on which it falls. The restoration of the observance of Veterans Day to November 11 not only preserves the historical significance of the date, but helps focus attention on the important purpose of Veterans Day: A celebration to honor America's veterans for their patriotism, love of country, and willingness to serve and sacrifice for the common good.

# Hillsborough County to Resume In-Person Quorums for Public Meetings Effective Nov. 1 Public participation for most meetings will

remain virtual

Hillsborough County, Fla. (Oct. 30, 2020) – With a statewide executive order regarding virtual government meetings expiring this weekend, Hillsborough County is ready to resume public meetings in a way that allows for in-person quorums while keeping officials, staff, and the public safe.

For months during the COVID-19 coronavirus pandemic, the Board of County Commissioners and dozens of other County-related agencies, boards, and councils have presided over public meetings virtually. Telephone and video meetings of local government bodies were authorized by Florida Gov. Ron DeSantis in mid-March. The latest extension of that order expires Sunday, Nov. 1 and is not expected to be renewed.

While officials will return to an in-person, socially distant meeting setting, it is imperative to continue to take steps to protect all participants. Therefore, most meetings will feature a hybrid format which allows for some board members to participate virtually as long as a voting quorum is present in person. A quorum is defined as the minimum number of members of an assembly that must be present at any of its meetings to make the proceedings of that meeting valid.

Also under the hybrid meeting format, non-essential staff, presenters, and the public will continue to participate virtually via audio or video. The exception is quasi-judicial meetings, such as land use meetings and Code Enforcement Board meetings, which have an expectation of due process. These meetings will offer the option for interested persons to speak and share documents in person or virtually. Anyone attending a quasi-judicial meeting in person will be required to wear a face covering, and temperature checks will be conducted at the door.

While County Commissioners and members of other boards and councils will be returning to County Center for meetings, the building remains closed to the general public at this time. To accommodate social distancing, some boards and councils will be meeting at other locations.

The new rules for public meetings are the result of extensive research and work by staff from several County departments and the County Attorney's Office. Hillsborough County will continue to conduct all public meetings with the safety of the public and staff in mind.
