

**TOWN OF MARBLE, COLORADO**  
**ORDINANCE NO. 7**  
**Series of 2002**

AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE TOWN OF MARBLE, COLORADO, CREATING THE TOWN OF MARBLE WATER BOARD AND ESTABLISHING THE APPOINTMENT OF COMMISSIONERS AND OTHER REQUIREMENTS AS SET FORTH IN SECTION 31-35-501 to 514, C.R.S. 1973, AS AMENDED.

WHEREAS, the Town of Marble is a Colorado statutory Town; and

WHEREAS, Section 31-35-501 et seq. C.R.S. 1973, as amended, allows a Town to create a Water Board for the purpose of operating a water supply system for the citizens of the Town and others; and

WHEREAS, the Board of Trustees finds that it is in the interest of the public health, safety and welfare to provide for a water supply for the Town and to create a Water Board for the administration of such water system and to collect fees:

WHEREAS, Section 29-1-204.2 allows for the Water Board to establish a separate governmental entity that is not subject to the laws of the State of Colorado regarding collection of revenues and payment of expenses.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MARBLE, COLORADO, THAT:

1. The Town of Marble Water Board is hereby created pursuant to Section 31-35-501 and Section 29-1-204.2 C.R.S., 1973, as amended, for the purposes set forth therein. The powers of the Water Board shall be those set forth in the applicable statutes as they may be amended from time to time.

2. The Water Board shall be considered to be a water enterprise fund pursuant to Article XX of the Colorado Constitution and C.R.S. § 29-1-204.2.

3. The Water Board shall consist of three members which members shall be appointed Town Trustees as selected by the Board of Trustees of the Town. The term of each commissioner shall be consistent with the term of election of each selected Trustee. Any Water Board commissioner may be removed from his position by a majority vote of the Town Trustees at any time. No bond need be posted by any Commissioner. The Water Board shall be required to hold a minimum of two meetings per year. There shall be no compensation for the Commissioners.


4. The Town of Marble Water Board shall be authorized to pass such resolutions as it determines necessary for the provision of a central water supply for fire protection as well as all other purposes consistent with the Statutes.

This ordinance shall become effective 30 days after publication.


