INFORMATION FOR NEW SERVICE APPLICANTS

**ONLY ONE HOUSEHOLD IS ALLOWED PER CONNECTION**

**STEPS NECESSARY TO ACQUIRE SERVICE FOR A STANDARD CONNECTION:**

Fill out a Hydraulic Investigation Request, pay the required fee, and provide a map or location of the property where service is requested. Allow a minimum of six weeks for the Engineer to complete the feasibility study. All hydraulic fees are used to pay the cost for the study and are non-refundable. **Any revisions made to the study after it has been processed will require the submission of a new hydraulic investigation and any applicable fees.**

**Cost for hydraulic study is based on number of connections.**

Installation fees for service after hydraulic study results are received will be:

Plus any additional costs to provide service to your property; such as road crossings and/or line extensions. Any additional costs will be disclosed in the final cost letter for your hydraulic investigation.

If any member or applicant is installing a concrete or asphalt driveway, or if a waterline extension is required to service the property, they must notify the corporation in writing and pay the cost to encase the waterline at every concrete or asphalt driveway location.

**Paperwork needed to acquire a connection:**

1. Service Application and Agreement
2. Right of Way Easement
3. Proof of Ownership of Property

All paperwork must be completed and turned in to the Office and all fees paid before the meter can be installed.

All paperwork must be completed, and connection fees paid within 60 days of the date of notification that service is available.

When service is available to you, your minimum monthly payment of **\$41.25** for residential service will begin. This fee will be due monthly regardless of water usage or connection to service.
