- b. Chairperson Bourne asked for a motion to discuss and possible action to finalize the Blue Ridge Fire District Fire Suppression Agreement document and launch the subscription process for 2022-2023.

Discussion took place re: Mr. Bourne noting that this Annual Agreement has been reviewed and approved by the County Attorney, Mr. Mark Byrnes, with emphasis on limited liability, indemnification and cost calculation. This Agreement brings more protection to the Community.

Ms. Meakin had concerns re: having enough equipment for a fire suppression service and the condition of the property in a Fire Wise perspective.

Chief Paine reminded the Board that Blue Ridge Fire District would call for mutual aid for any house fire as they require additional fire fighters than those regularly on BRFD shift. This Agreement has Board approval from February; the Agreement is between BRFD and the property owner, not renter; education is key to prevention and this Agreement will bring the community together to provide fire service.

Ms. Hawke noted grammatical revisions needed on the last page from "to me" to "to Subscriber;" and limit needs an "s" to limits.

Ms. Hawke made the motion; Ms. Varns seconded. All voted Yes.

The Motion passed.

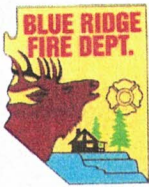
