General Information and Regulations

* **BOOTH SPACE ASSIGNMENT:** You will be advised of booth space number at time of check in.

BOOTH SIZE: Booth space size is approximately 10' x 10'. No sharing of booth space

BOOTH DISPLAY: All items must be displayed on tables, stands or other display items.

Tables are

Required and **NOT** provided by the event coordinators. **No** items to be displayed on blankets.

ELECTRICITY: Electricity will **Not** be provided with a regular outdoor space rental. If electricity is needed please bring a generator or battery operated lights to hand inside your tent.

We do have very limited spaces with electricity and those spaces have a \$10.00 fee in addition to the regular vendor fee and reserved mostly for Food Vendors. Electricity will be reserved in order as application are received. You must call prior to sending in your payment to confirm we have electricity available.

Sales Tax: If applicable, vendor are responsible for collecting Florida Sate Sales Tax and remitting to the Florida Department of Revenue.

FOOD SALES: The sale of food items is limited to **Food Vendors only.**

HEALTH CERTIFICATE: Food vendors must have a valid health certificate and have it with you during the event. If you do not have annual one, please come with a **Money Order** for \$91.00 in case there is an inspection by the state. If there is a state inspector on site and a food vendor fails that inspection they will need to immediately correct the violation or leave the event and no refund will be given.

SET UP: You may begin at Noon on Saturday, November 24th. All exhibitors are required to stay and maintain their display areas throughout the entirety of the event. No break down until 8 PM for vendors. The roads will be closed to vehicles during the event.

CLEAN UP: Vendors are responsible for the clean-up of their area and must not leave behind any trash or boxes.

WEATHER: Be prepared for rain, wind, sun, heat and cold.

RAIN DATE: There is NO RAIN DATE scheduled for this event.

NO REFUNDS once vendor fee is paid.
