## **Bloomfield Police Department Monthly Report for April 2020**

This is the monthly report for the Month of April 2020 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Sunday, April 12<sup>th</sup> at approximately 6:45pm officers received a motor vehicle (motorcycle) theft which occurred on Powers Lake Road in the area of Hwy U. The complainant reported that person(s) unknown had taken a black 2006 Harley Davidson motorcycle which had been parked on the shoulder of the road after breaking down. This incident remains under investigation.

On Wednesday, April 15<sup>th</sup> at approximately 4:49pm officers responded to a residence in the 1400 block of Eastwood Road for a possible bail jumping complaint. At the conclusion of the investigation a charge of bail jumping has been forwarded to the Walworth County District Attorney's office for a 34-year-old female who fled the area prior to officers' arrival.

On Saturday, April 18th at approximately 8:05am officers responded to a residence in the 1100 block of Tombeau Road for a theft of a motorboat complaint. This incident remains under investigation.

On Sunday April 19th at approximately 7:44pm officers responded to a residence in the 1000 block of Violet Road for a domestic disturbance complaint. At the conclusion of the investigation a 30-year-old male was arrested then confined in the Walworth County Jail. Charges of disorderly conduct and bail jumping have been forwarded to the Walworth County District Attorney's office.

On Monday, April  $20^{\rm th}$  at approximately 10.50am officers responded with the Bloomfield-Genoa City fire department to the 600 block of Hafs Road for a wood burning stove fire. The fire was ultimately extinguished.

On Thursday, April 23<sup>rd</sup> at approximately 7:39am officers responded to a single vehicle roll over crash which occurred on Hwy 12 in the area of Hwy U. At the conclusion of the investigation a 24-year-old male was issued a non-traffic citation for possession of marijuana and for possession of drug paraphernalia. There were very minor injuries associated with this crash.

On Sunday, April 26<sup>th</sup> at approximately 1:24am officers responded along with the Bloomfield-Genoa City Fire Department to a residence in the 1200 block of W. Lakeshore Dr. for a boat fire. The fire was ultimately extinguished. This incident remains under investigation as the cause and origin of the fire is being considered suspicious.

During the month of April 2020, the Bloomfield Police Department responded to 1308 calls for service compared to 788 calls for service during the month of April 2019. During the month of April 2020, the police department affected 17 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 124 arrests during the month of April 2019.
