I received my M.B.B.S. from Dow Medical University in Karachi, Pakistan. My parents motivated me to become a doctor. I chose Physical Medicine & Rehabilitation as my specialty because I had an interest in anatomy and musculoskeletal disorders.

My family's friends - a husband and wife - are a surgeon and OB/GYN, respectively. They built themselves up from almost nothing, and with hard work they became very successful. 

# from the editor

Laughter Is Not Enough

Oh no! Not another article about Robin Williams. But this one, I promise, will speak to you as a physician. It will deal squarely with the mistakes that were made, and are still being made, in these cases. This is information you need to know.

First, let's talk about the shock we all felt. Of all people, not him! He was always so all-fired happy on the outside! Of course, why should we be surprised that a talented actor (or even a patient or colleague) would show us only what he wanted us to see? Robin's inner life, his depression, were not shared with the hundreds of millions of people who adored him, for fear that such a revelation would detract from his effectiveness as a comedian. Being a comedian, pure and simple, was his job, and no one would watch a depressed comedian. Thus, his private pain remained very private, resulting in a marked dichotomy between who he was and who he appeared to be. He felt constrained by his chosen profession to separate who he was on the inside with who he appeared to be on the outside. The simple human action of sharing our pain with others of our species, an effective coping mechanism, was lost to him. This mistake sealed his doom.

Do you know anyone else who feels constrained to hide his private internal life

from those who idolize him? Take a look in the mirror. We are taught from the first day of medical school to be emotionally distant from patients (our 'audience').

Another mistake is to presume that someone who laughs a lot is somehow immune to depression. Laughter may help a multitude of ills, but doesn't work so well for depression. Robin's case should conclusively put that fallacy to rest. The notion that we can get rid of the darkness that is within every one of us by laughing is ludicrous. Laughter is no more effective at solving our psychic pains<sup>1</sup> than are drugs or alcohol. I'm not saying laughter isn't good. It works quite well to help us cope with everyday stresses and strains - it just doesn't work for depression. There are only two treatments for depression that work medicine and talk therapy. As for the other treatments patients try: Vitamins, exercise, denial, accumulating toys, alcohol, drugs, and sex - notoriously ineffective, although that fact doesn't stop most depressives from trying to rely on them.

The third mistake is to believe that if we don't talk about depression, it will somehow go away. We're smack in the middle of a major epidemic that dwarfs all other current epidemics, killing some 40,000 Americans a year, causing untold suffering, yet the only time we hear about it is when a celebrity is affected. On a normal news day, if you were to watch television news reports all day long and read every major newspaper, you likely would not find one mention of this problem. Why not? It's the old stigma stemming from Puritan times when depression was viewed as moral and spiritual weakness. Even when the media is forced to step up, when the victim is a very public figure, the media tells us not to talk about the details of the suicide because it would be "too painful for the family." For the family, or for the rest of us? "Let's just talk about the good he did, we can all be comfortable with that." Thus a golden opportunity to discuss depression and suicide, to bring it to the forefront of society's

consciousness, is lost.

The fourth is to believe that, because doctors are so smart, this will protect us from depression. In reality, doctors often do get depressed (and they shockingly commit suicide two or three times as often as everyone else)! Why? It's known that stress contributes to depression and we doctors have suffered unprecedented stresses in recent years. Who wouldn't get depressed? Yet for us, the stigma of depression is even greater than for the general public. To admit we are depressed is to put our practice in jeopardy, literally. Thus, the very physicians who the public needs to look to for leadership out of this epidemic can be paralyzed into inaction. We are far too reluctant to make this diagnosis in patients, and especially in our patient/colleagues (ourselves). In addition, physician paralysis in this one area reflects part of a larger challenge, how to improve healthcare across the spectrum of diseases. It is glaringly obvious that we cannot have a healthy healthcare system when those who provide the care are stressed out, burned out, mentally and physically exhausted, depressed, and even suicidal.

What to do? Probably the first thing is to start asking the question, the right question; an ability we take pride in as a critical skill for physicians; a skill we use every day. "Are you depressed?" is a pretty simple question. "Are you suicidal?" is a little harder, but shouldn't be. It is a sensitive, caring, and eminently appropriate question. We need to start using these questions with our patients, with our families, and with our colleagues. Then make sure they get effective treatment. Anything less will not stem the tide of this epidemic.

Another step, one with a longer time horizon, is to ask society to accept the fact that the heavy hand that they have laid on the backs of physicians needs to be lightened up a bit. The institutions<sup>2</sup> who are pressing physicians to work harder, to fill out more forms, to obtain more certifications, to justify every single little thing

that we do - need to put their whips back in their holsters. They need to understand that this approach will not improve healthcare. We need to ask our medical organizations with a presence in Washington, Lansing, and board rooms of corporations to put this issue to the forefront. Simply put, we need help. We cannot fix the current mess without help. The old days, when "Physician Heal Thyself" was the byword, are, and should be, long gone.

- <sup>2</sup> I include the usual suspects: Insurance companies, government agencies, the legal profession as whole, hospitals as a whole and hospital administrators as individuals




# SCMS Members and Their Families Are Invited to Serve Breakfast on Saturday, October 4, 2014

### MAY MEMBERSHIP MEETING MINUTES

The annual meeting of the Saginaw County Medical Society was held on Tuesday, May 20, 2014, at Horizons Conference Center in Saginaw. Meena Ramani, MD, President of the Saginaw County Medical Society, called the meeting to order at 7:04 p.m. Dr. Ramani welcomed the SCMS Foundation Essay Contest Winners and their parents, and the evening's speaker, Josh Richmond, Director, Membership & Political Fundraising of MSMS. Dr. Ramani thanked Key Providers in attendance for their ongoing support of SCMS programs: Covenant HealthCare Laboratory and Luther Manor.

Dr. Ramani conducted the following business of the SCMS:

- The minutes of the April 2014 Meeting were attached to the Agenda and published in the May Bulletin. MOTION: Accept the April 2014 Meeting Minutes as printed. MOTION APPROVED.
- The CAN Council Great Lakes Bay Region has launched a \$2.7 million capital campaign to allow for the enhanced continuation and expansion of CAN programs as they meet the needs of abused and neglected children and at-risk families throughout our region. The Dow Corning Foundation has issued a \$300,000 matching grant for the month of May only. Gifts from the medical community will additionally be matched by an anonymous physician donor, so gifts are worth triple to the campaign. All those attending were encouraged to donate and were provided a donation form and return envelope.
- Dr. Dan and Alyce Wechter were presented the 2014 MSMS Community Service
  Award for their work with expectant mothers, and providing services for free if they cannot afford medical care.
- Dr. Ramani installed M. Sohail Jilani, MD, as the new SCMS President and

- presented him with the President's medallion. Dr. Jilani then gave his presidential address.
- Dr. Jilani awarded a plaque to Dr. Ramani thanking her for her leadership service to the SCMS. Dr. Ramani gave a farewell address to the membership. Dr. Jilani took over the meeting as President.
- Dr. Jilani welcomed M. Yahya Khan, MD, Chair of the Nominating Committee to the podium. Dr. Khan presented the Slate of Officers for 2014-2015, with the change that Anthony J. Senagore, MD would be replaced by Steven J. Vance, MD as an Alternate Delegate. MO-TION: Accept the Slate as revised by the Nominating Committee for 2014-2015. MOTION APPROVED.
- The SCMS annual meeting was adjourned.

Dr. Jilani called Matthew D. Deibel, MD, SCMS Foundation President, to the podium.

Dr. Deibel called to order the Annual Meeting of the SCMS Foundation, and conducted the following business:

# CARDIOVASCULAR SURGEON JOINS ST. MARY'S/MCVI TEAM





CARF International announced the Covenant HealthCare Rehabilitation Program has been re-accredited for a period of three years for:

The latest accreditation is the sixth consecutive three-year accreditation the international accrediting body, CARF, has awarded to the Covenant rehabilitation program.

This accreditation decision represents the highest level of accreditation awarded to an organization, and shows the organization's substantial conformance to the CARF standards. An organization receiving a three-year accreditation has put itself through a rigorous peer review process. It has demonstrated to a team of survevors during an on-site visit its commitment to offering programs and services that are measurable, accountable, and of the highest quality.

CARF is an independent, nonprofit accrediting body whose mission is to promote the quality, value, and optimal outcomes of services through a consultative accreditation process that centers on enhancing the lives of the persons served. Founded in 1966 as the Commission on Accreditation of Rehabilitation Facilities, and now known as CARF International, the accrediting body establishes consumer-focused standards to help organizations measure and improve the quality of their programs and services.

The Covenant rehab program is located at the Michigan campus with 41 inpatient beds. Patients can spend anywhere from four to thirty days on the unit depending on their diagnosis and needs, however the average patient stays just over eleven days. Typically, patients in the program are recovering from stroke, brain injury or trauma, although orthopaedic and cardiac patients commonly receive treatment. Last year, 865 patients were discharged from the program.

### Be Disaster Aware, Take Action to Prepare

While disaster preparedness drills at work are common practice, Covenant wants our medical colleagues and community to be prepared for disasters at work and at home. To support this, the

community is invited to Bliss Park on National Emergency Preparedness Day, Tuesday, September 30. The nonprofit alliance works with CMU College of Medicine to manage the Saginaw-based clinical practices and assist with educational opportunities for students and residents.

The CMU Medical Education Partners six-member board issued a statement after the meeting: "Terry Lerash has vast experience in medical education, and his strong relationship with physicians will serve well CMU's efforts to have a first-class medical school with a top-notch medical residency

program. His collaborative style will help us continue to move forward to bring new physicians to the Great Lakes Bay Region."

Lerash, who also has experience with Covenant HealthCare, Michigan Cardio-Vascular Institute and McLaren Hospital, has a master's degree in administration from CMU. He started his role as CMU Medical Education Partners executive director immediately, and he called his first meeting at 8 a.m. Wednesday, September 3, with directors and managers.

The CMU College of Medicine is the nation's 137th medical school, created to address an anticipated shortage of 4,000 to 6,000 physicians in Michigan by 2020. Students spend their first two years of study on CMU's main campus in a state-of-theart 60,000 square-foot-facility. The third and fourth years will be spent in clinical training at a number of medical facilities across central and northern Michigan, including Covenant HealthCare and St. Mary's of Michigan.

A \$25 million, 46,000-square-foot College of Medicine educational facility is under construction on the Covenant Health-Care campus in Saginaw. Construction will be complete by May 2015, in time for the inaugural students' third year of study. Planning is underway for a facility on the St. Mary's of Michigan campus. Once approved, the building would be ready to serve students when a large portion of the second class of 104 students starts studying in Saginaw in 2016.

St. Mary's of Michigan and Covenant HealthCare receive grant dollars from National Cancer Institute as part of the Michigan Cancer Research Consortium

Grant enables the consortium to participate in groundbreaking clinical trials

St. Mary's of Michigan and Covenant HealthCare were named as participating cancer research sites in the Michigan Cancer Research Consortium (MCRC) Community Oncology Research Program (NCORP). Saint Joseph Mercy Health System was awarded more than \$10 million to lead the MCRC consortium, which enables patients throughout the 13-hospital consortium to participate in cutting-edge clinical trials offering access to the top cancer treatments available. St. Mary's of



Michigan is one of the founding members of the MCRC established in 2001. Covenant is a participating site through the membership of St. Mary's of Michigan Oncology Research Program.

Trials currently underway include utilizing promising targeted agents based on the genomics of the patient's tumor, testing possible cancer vaccines and new radiation strategies to treat cancer. Trials evaluating methods to reduce the side effects of cancer treatments and improve quality of life are also an important goal of the NCORP.

Saginaw medical oncologist, Dr. Ernie P. Balcueva, is the Medical Director of the Oncology Research Program and Lead Principal Investigator at St. Mary's of Michigan. He stated that the MCRC has been one of the premier Clinical Oncology Research Program in the country. "MCRC brings a variety of high quality research studies to the community of Saginaw and has been one of the top accruing sites consistently in the nation. St. Mary's of Michigan has also been awarded the Silver Certificate of Excellence for study participation by the National Cancer Institute for two consecutive years; a recognition no other member hospital has received and an acknowledgement which the Saginaw community can be proud of."

After a highly competitive process, the MCRC was selected as one of 34 community sites across the country to receive the five year NCORP grant. In addition, the MCRC will be participating in the latest cancer care delivery research to examine the most effective and efficient methods of delivering cancer care, including how to overcome lack of access in some underserved communities.

"For patients to be able to take part in the highest quality research treatments right in their own communities is a tremendous opportunity," said Philip Stella, MD, principal investigator, Michigan Cancer Research Consortium, Saint Joseph Mercy Health System. "At the same time, we are assisting the National Cancer Institute to increase

their access to real world health care delivery in the community, where the majority of cancer patients receive their care."

The Michigan Cancer Research Consortium grant application received the highest grant impact score, which demonstrates the strength of its oncology research program and recognition by grant reviewers that MCRC can successfully assist the National Cancer Institute to improve cancer outcomes in the communities served.

All of the grant dollars will be used to fund infrastructure and staff, who will assist patients to participate in more than 120 clinical trials that are available.





## **♦** Feds Target Pervasive Health Care Provider Tax Scam

As reported previously, MSMS was informed of several instances of fraudulent tax



return filings involving Michigan physicians and dentists whereby legitimate tax returns are filed and a notice is received that the return has already been filed. The problem is national in scope, reaching into 49 states and the District of Columbia, and appears to involve a disproportional number of health care providers. Health care providers affected thus far include physicians, physician assistants, APRNs, dentists, podiatrists and pharmacists. The source of this identity theft (i.e., the social security numbers, addresses and other information necessary to file a tax return and obtain a refund) is still unknown.

MSMS has learned that the New Hampshire Office of the U.S. Secret Service, which specializes in this type of IRS fraud investigation, is leading a national investigation. The U.S. Secret Service agent assigned to this case is collecting names of physicians and other health care providers who have been affected by this IRS scam. # **♦**MSMS Working With Medicaid Program on Uplift Payments

MSMS is continuing to work with the state Medicaid program regarding the primary care uplifts from the Medicaid health plans. MSMS is seeking clarification on issues causing delays in physicians receiving the rate increase as allocated in the ACA. With MSMS assistance, Medicaid will provide a detailed tutorial about data collection, attestation, the formula for payment under capitation and timelines for reimbursement. This information should address many of the causes for the delays. MSMS will notify practices as soon as this free, online presentation is available.

If you are a primary care physician and have questions about your rate increase, the Medicaid program is asking that you directly contact the Medicaid managed care plans in which you are enrolled. ## **❖**Make Sure You Are Up-to-Date on CME Requirements

If you are among the next one-third of Michigan physicians who need to renew their licenses, you have until January 31, 2015, to complete your CME requirements. Physicians are required to complete 150 hours of CME credits every three years as a condition of relicensure, and they are due at the time of your license renewal. The minutes of the March 18, 2014, Board meeting were reviewed. **MOTION:** Approve the March Board Meeting Minutes. **MOTION APPROVED**.

Dr. Dean presented the Treasurer's Report for March 2014. He also reviewed 2012 Form 990 for the period from December 1, 2012, through November 30, 2013. **MOTION:** Approve the March Treasurer's Report and 2012 Form 990. **MOTION APPROVED.** 

## **OLD BUSINESS**

- 1. MSMS House of Delegates The 149th Annual MSMS House of Delegates will be held at The Henry in Dearborn from Friday, April 25 through Sunday, April 27. The SCMS is entitled to 11 delegates based on membership, and the following Delegates have indicated they will attend (in order of seniority): Drs. Scott, Dawis, Paidipaty, Nahata, Z. Khan, Walter, Ramani, Dedicatoria and M.Y. Khan; and Alternate Delegates to be seated as Delegates, Drs. Veverka and Nallani. Dr. M. Sohail Jilani has offered to serve as a backup if a Delegate is unable to attend. Dr. Thomas J. Veverka has agreed to accept nomination for the open District 8 Director seat. Drs. Syed Akhtar, Rustico Ortiz and Patricia Valia are eligible to receive 50 year pins at this year's House of Delegates. Dr. M. Yahya Khan will serve on the Committee on Rules and Order of Business to consider late resolutions to the HOD. Dr. Mildred J. Willy will serve as a Delegate for the Michigan College of Emergency Physicians.
- 2. 10th Annual Health Fair Joan report-

ed that the 10th Annual Health Fair "The Doctor Is In!" held on Saturday, March 22, 2014, was a success again this year. Attendance was up to 1,100, and 350 of those who registered had never been to the Health Fair before.


Michigan Blood registered 22 donors, 14 of which were able to donate, and two were first time donors. The East Side Soup Kitchen received a nice donation of non-perishable food donated by the public; and the Saginaw County Health Department and Sheriff's Department collected more than two 30 gallon containers of old, unused or unwanted medication through Dump Your Drugs.

3. Health Delivery, Inc. (HDI), Request of Letter of Support – At the March meeting, the Board reviewed a letter from Monica Woods asking for SCMS support of HDI and their Community Health Center programs. A discussion was held among Board members in regards to HDI being competitors of SCMS primary care physicians. It was also noted that HDI receives Medicaid subsidies that others do not. It was noted that only five HDI physicians are SCMS members (Drs. Bernardino, Coughlin, Hanna, Passal and Pinnell). It was the general consensus of the Board that the SCMS would be more supportive of HDI if their physicians were SCMS members. The Board invited Drs. Brenda Coughlin and Douglas Saylor to the April Board meeting to discuss a mutually supportive environment. Drs. Coughlin and Saylor gave an overview of services provided by HDI, and their sources of funding. Dr. Saylor indicated he completed his SCMS membership application, and gave it to HDI's accounting office to process payment. After discussion, it was agreed that the SCMS would send a letter of support for HDI and their programs to the appropriate legislators. **MOTION:** Approve letter of support for HDI. MOTION APPROVED. Dr. Coughlin offered to

include SCMS membership information in new HDI physician orientation packets.

4. CMU Healthcare CME Fees – The SCMS has been notified we must now pay for CME accreditation through CMU. The application fee is \$150, plus \$125 per credit hour. Our programs are approved for 1.5 hours, so each CME program we offer at our meetings would cost \$337.50. Joan checked with MSMS, and they are able to accredit and track CME for us at a flat rate of \$200 per event. This fee is deeply discounted for county societies, as regularly charged fees to outside organizations are \$1,200-\$2,000 based on the number of hours. Dr. Anthony Senagore addressed the issue of the CME fees. He said there has been a transition in funding support from Synergy to CMU, and that CMU negotiates differently than Synergy with in-house

facilities (St. Mary's of Michigan and Covenant HealthCare). It costs CMU \$60,000 to \$75,000 per year to accredit CME programs. Several Board members stated the SCMS should not be charged CME fees because SCMS physicians are teaching the residents and medical students. Dr. Senagore replied that not all SCMS physicians teach, but those that are CMU community educator faculty are in line to receive enhanced Medicaid reimbursement which has value. One of the Board members stated that primary care physicians already receive enhanced Medicaid reimbursement. Dr. Senagore stated that enhanced Medicaid reimbursement through CMU is for all specialties, not just primary care physicians. Joan noted that the potential annual cost for CME accreditation of SCMS programs is approximately



\$1,200. The Board agreed to table the issue, and asked Dr. Senagore to take Board concerns to CMU leadership and report back at the May Board Meeting.

### **NEW BUSINESS**

- Applications for Membership There were no applications for review.
- Slate of Nominees for 2014-2015 Dr. M. Yahya Khan, Chair of the Nominating Committee, presented the Slate of Nominees for 2014-2015. The Slate will be voted on by the Membership at the May 20, 2014, Meeting. MOTION: Accept the Slate of Nominees for 2014-2015 as presented. MOTION APPROVED.
- 3. <u>Unpaid Dues Update</u> The Board reviewed the list of members who have not yet paid their 2014 membership dues. Board members were asked to contact those they know on the list and encourage payment.
- 4. 5th Annual SCMS Foundation Golf Outing This year's Golf Outing will be held on Saturday, June 7, 2014, at the Saginaw Country Club. Board members were given sponsorship and team registration forms.
- 5. Health Fair Vendors It has been SCMS policy that podiatrists and chiropractors are not allowed to have booths at the annual SCMS Health Fair. The minutes of the April 15, 2014, Board meeting were reviewed. **MOTION:** Approve the April Board Meeting Minutes. **MOTION APPROVED.** 

Dr. Dean presented the Treasurer's Report for April 2014. MOTION: Approve the April Treasurer's Report. MOTION APPROVED. Dr. Dean then indicated the SCMS office computers need to be replaced in the very near future, and asked the Board to approve an additional \$1,800 for the purchase of two new computer towers and IT fees associated with the installation. MOTION: Approve \$1,800 for purchase and installation of two new computer towers. MOTION APPROVED.

## **OLD BUSINESS**

- 1. MSMS House of Delegates A summary of the 149th Annual MSMS House of Delegates held at The Henry in Dearborn in April was attached to the Agenda. The 150th Annual MSMS House of Delegates will be held from Friday-Sunday, May 1-3, 2015, at the Amway Grand in Grand Rapids. Delegates were asked to mark their schedules to attend, and Alternate Delegates were advised they may be asked to attend if enough Delegates cannot.
- SCMS Foundation Golf Outing The 5th Annual SCMS Foundation Golf Outing is scheduled to be held on Saturday, June 7, 2014, at the Saginaw Country Club. Board members were asked to sponsor and golf.
- 3. Slate of Nominees for 2014-2015 Dr. M. Yahya Khan, Chair of the Nominating Committee, led discussion on the Slate of Nominees for 2014-2015 that was approved at the April 15, 2014, Board

Meeting. Dr. Anthony J. Senagore was originally chosen by Dr. Ernie Yoder of the CMU College of Medicine to be the CMU representative to the SCMS Board. Therefore, Dr. Senagore was included on the Slate as an Alternate Delegate since there is no provision in the Bylaws for a representative of this type. Dr. Senagore advised the SCMS that CMU has realigned duties, and Dr. Steven Vance will now serve as the CMU representative to the Board. MOTION: Remove Anthony J. Senagore MD as an Alternate Delegate on the 2014-2015 Slate of Nominees and replace with Steven J. Vance MD. MOTION APPROVED. Dr. Khan will inform SCMS members of the change at tonight's membership meeting prior to the vote being taken to approve the Slate.

- 4. Members Dropped for Nonpayment of Dues The Board reviewed the list of members who have not paid their 2014 dues and who were dropped by the SCMS and MSMS. The members can be reinstated with payment of their dues.
- 5. <u>CMU Healthcare CME Fees</u> After the April Board Meeting, Dr. Anthony Senagore contacted CMU about the issue of charging the SCMS for CME programs. CMED has agreed to support the SCMS gratis. Dr. Senagore trusts that SCMS members will appreciate the benefits.
- 6. Health Fair Vendors It has been SCMS policy that podiatrists and chiropractors are not allowed to have booths at the annual SCMS Health Fair. Participation has been limited to SCMS physicians and medically related businesses. Businesses owned by physicians who are not SCMS members are also not allowed. Dr. Elvira Dawis questioned the policy, stating that many physicians now refer to chiropractors, and she felt they offer a benefit and should be allowed, citing personal experience. The Board discussed that while there are good and qualified chiropractors, there are

many that recommend healing methods and practices contrary to what physicians recommend, namely, opposition to childhood immunizations. Several Board members stated that chiropractors are now covered by health care insurance. Joan noted that no podiatrists have asked to participate in the Health Fair. Each year, Joan gets calls from chiropractors asking to participate. **MOTION:** For a trial period of one year, allow no more than two (2) chiropractic offices to submit an application to the SCMS Board to participate in the Health Fair. Each application will need two physician sponsors and must be approved by the SCMS Board. The Board will revisit the issue after the 2015 Health Fair to consider making it permanent policy. MOTION APPROVED.

## **NEW BUSINESS**

- Applications for Membership Dr. Talati presented the following application for first reading:
  - a. Douglas J. Saylor, MD Ob/Gyn, Health Delivery, Inc., Chief Medical Officer and Staff Physician, sponsored by Drs. Brenda M. Coughlin and Donald B. Passal.
- 2. Fraudulent Tax Filing Legal Alert Dr. Ron Barry attended the Board meeting to talk about the number of local physicians and dentists who have been victims of tax fraud this year, including he and his wife. He was aware of at least 28 physicians in the Saginaw area who were affected. Some fraud included tax returns being filed in the name of a physician in another state, such as Oklahoma, as well as refunds via a T-Mobile debit card. Dr. Barry wanted to know if he should contact the media in his position as Chair of the Press and Public Relations Committee to publicize the issue. His thought was we need to address it at the local level so others know what is happening. and perhaps something can be done to

find the criminals. It was decided that Joan would work with Dr. Barry to prepare a survey that will be sent to SCMS physicians and the Saginaw Dental Society asking for information if they were affected by fraud. Joan will then compile the results and work with Dr. Barry to try and find a common denominator.

- 3. SCMS Board Representative to CMU **College of Medicine** – Tabled until the June 17 Board Meeting.
- 4. SCMS Foundation Dr. Richard Hausler, Secretary/Treasurer of the SCMS Foundation, gave an overview of the 2014 Foundation Annual Report that Dr. Matt Deibel, Foundation President, will give at tonight's Foundation Annual Meeting. Dr. Hausler is also ending his term as Retiree Representative to the Board, and gave a few exit remarks to the Board on several matters, including mentoring younger physicians and encouraging them to be leaders.

Dr. Dean presented the Treasurer's Report for May 2014. **MOTION:** Approve the May Treasurer's Report. **MOTION APPROVED.** 

### **OLD BUSINESS**

- 1. SCMS Foundation Golf Outing Dr. Jilani reported that 23 teams participated in the 5th Annual SCMS Foundation Golf Outing on Saturday, June 7, 2014, at the Saginaw Country Club. The Foundation will receive approximately \$16,700 after expenses.
- 2. CMU Health Dr. Vance addressed the Board about the differences between "enhanced" and "uplifted" Medicaid programs. The Medicaid PPAP program is aligned with public universities and was extended to Covenant HealthCare and St. Mary's of Michigan. CMU College of Medicine, Covenant HealthCare and St. Mary's of Michigan employed physicians are enrolled in the Medicaid enhancement program, so that is why some physicians are receiving additional funds. Dr. Vance reported that faculty from out of the area will also have Medicaid enhancement, but will receive a check directly from CMS. Medicaid "uplift" is a two year program that is currently in effect for primary care physicians. Board members were again instructed to submit their CV to the respective residency program directors for consideration of appointment by CMU College of Medicine. Dr. Vance also presented a list of those physicians who have been appointed Community Educator Faculty as of May 28, 2014. The Board also discussed with Dr. Vance the physicians who recently resigned from CMU Health and the reasons for their departure.
- 3. <u>SCMS Board Representative to CMU</u> <u>College of Medicine</u> – Dr. Ramani ques-

tioned having a SCMS Board member on the CMU College of Medicine Board since we have one of their representatives, appointed by Dean Yoder, on our Board. Dr. Dean indicated academic boards are much different than the SCMS Board, and are constantly meeting and working on issues. Dr. Vance will look into what board would be the proper venue for SCMS representation and will report back to the Board. The educational faculty board and curriculum committee were both suggested as possibilities.

- 4. Retiree Representative Former Retiree Representative, Richard C. Hausler MD, resigned his position at the May 20, 2014, Board Meeting. Neil W. Love MD expressed an interest in the position, and has attended the past several Board meetings. MOTION: Appoint Neil W. Love MD as the Retiree Representative to the SCMS Board. MOTION APPROVED.
- Saginaw County Health Department The Saginaw County Health Department

- is searching for a new medical director. An informational sheet with the requirements was distributed to all physicians attending the Board meeting.
- 6. Physician Assistant Preceptors Joan reported that PA students at CMU are having a difficult time finding preceptors for their PA students. Joan asked if anyone would be interested in serving as a preceptor. Several physicians reported they have contacted CMU in the past to get PA students, but their calls have not been returned. It was mentioned that perhaps the difficulty of securing preceptors was because of the amount of time physicians must spend on EMRs, Meaningful Use, etc., thereby limiting the time they have available. physicians and office managers to determine interest. The information will then be compiled and given to CMU.

7. Dr. Ramani's Projects – Dr. Ramani reported that she was still working on her efforts to stop bullying and a gun buyback program. She reported that she discussed both issues with Saginaw County Sheriff Bill Federspiel. It was suggested that the school put out a mass text message to the students when they return in the fall with information on who to contact if they are being bullied. Dr. Ramani did not know whose number should be given to the students. Joan told her that there is a bullying website www. stopbullying.gov and the Lifeline phone number for this purpose is 1-800-273-TALK (8255).

In regards to the gun buyback program, the Sheriff would like to speak with the SCMS Board at the August or September Board meeting to discuss the details. Dr. Ramani suggested the Sheriff's Department could have a booth at the SCMS Health Fair to collect guns. After discussion, it was decided that the Health Fair was not the proper venue to collect guns. They could have a booth on gun safety, such as how to secure firearms. Dr. Ramani reported that she talked to a physician in the Public Health Reference Committee Hearing at the MSMS House of Delegates in April, and learned that four other counties are currently working on this problem. Joan will contact MSMS and try to get the names of those counties.
