President's Opening Statement -- David Smith

Reports of Committee Chairs

Chuck Wilcox – Recreation

- The annual picnic will be held on Saturday, August 8th at noon. Hot dogs and hamburgers and soft drinks will be provided. There will be games for the children.

Ron McCracken -Roads

HVPOA Road committee report For year 2014-2015:

Road Paving:

Last fall we paved the remaining 1285 feet of Hidden Valley Drive running fro the Lynch house, (top of the hill after the Valley Rd. intersection), almost to the Marina. Prior to paving we removed 40+ rocks that had popped thru the old surface.

Major Work:

We removed a failed culvert on Valley Rd. and replaced it with a new one sited about 40 feet away to facilitate better water flow. The road cuts were also repaved.

Gravel was added to the inner curves on the 'loop' to combat erosion that was occurring.

Also, a new catch basin was added to the 1st beach parking area to remove water that was eroding the driveway entrance to the beach.

Tree Trimming:

NEEC came thru the Valley last year and did a great job clearing out trees in most areas. This led to better winter road conditions as sunlight was able to warm the road surfaces.

We also had Dan Libby in for 4 days on the continuing quest to trim the roadways on the non power line side.

Fall Maintenance:

Leaves, leaves, and more leaves. All find their way into the culverts.

Winter Maintenance:

This was, by all accounts a very cold and long winter. Things froze early and stayed that way. As usual, we had a period of severe icy weather with sleet. This prompted sanding that would just get iced over in a few hours, prompting more sanding. There were a few complaint calls.

Sweeping:

Sweeping was done just before Memorial Day and came in at \$870 (vs. \$1020 last year).

Thanks to Ray Graham for taking the sand.

Roadside Mowing:

As we've done in the past, plans are to mow twice. Once prior to 4th of July and again in late August, prior to Labor Day.

Speed Bumps:

Painted on June 24th. Thanks to the crewmembers Tom Kennedy, Tom McPhail, Jeff Blackett, Jerry Wilson, and Jack Griffin. I think we finished in record time this year, about 2 ½ hours.

Plans are to re-build (widen and pave), section of Valley Road from Paul Dubuc's house to Bill Endres house. This is the section left undone from the loop to Ridge Road.

Replace a culvert across Bishops Gate Rd. at the intersection of Heritage.

Report on Beach Improvement- Mark Evitts

As discussed at our Board of Directors meeting on Saturday 6/27, our two community beaches have suffered from erosion problems for years and despite best efforts by the Association, the problems have never been solved. The constant erosion sweeps any sand put on the beaches into the pond which has resulted in a build-up of sand in the water and very little sand on the beaches. Much of the beach area is rocky and uncomfortable to sit and walk on. The desired solution is to have sand placed on the beaches stay on the beaches.

This morning I called Dale Keirstand (Phone number, 603-271-4058) at New Hampshire's Water Pollution Division in Concord. Mr. Keirstand is an environmentalist and coincidentally he visited Lower Beach Pond approximately 10-years ago when Bob Shockley and Fred Antil tried to address the problem at First Beach. Mr. Keirstand could not recall the specifics or the outcome but felt that Bob and Fred were on the right track at the time.

Highlights of my conversation are as follows:

- 1) The state has an extremely high bar for both removing sand from the water and removing if from below the high watermark when the pond is drawn down. The reason for this is sand often contains phosphorus and disturbing the sand results in phosphorus being kicked up and into the water. When this happens, unwanted plant growth and poor water conditions often follow. Based upon my conversation, I do not believe we can accomplish removal of the sand that currently resides in the pond.
- 2) Mr. Keirstand feels the best solution for our problem is the installation of perched beaches on Hidden Valley's First and Second beaches with some modification of the water flows above the perched beaches. This solution is somewhat complicated (but likely not unsolvable) on First Beach as there is a need to keep some of the beach open to the water for the launching and pulling of boats.

The problem we face with our beaches is not uncommon in the Lakes Region. As noted during our meeting on Saturday, the 19-mile public beach on Winnipesaukee is a perched beach. Also, I found that the Ashland town beach on Little Squam is a perched beach. I plan

to visit both of these this summer and when I do I will take pictures and send them to the Board. A google search of "perched beaches NH" results in examples of perched beaches throughout the lakes region at private homes. They can be elaborate or simple. I have a small, simple perched beach in front of my house that board members can visit at their convenience.

3) The other key takeaway from my conversation with Mr. Keirstand is there are marine contractors that specialize in projects along the shorelines of New Hampshire's lakes and ponds. These firms work with the State's shoreline protection act constantly and they know how to secure permits to get work such as perched beaches done. The contractors Mr. Keirstand recommended are NH Environmental Consultants (603-387-9684) and Folsum Design Group (603-393-5751). Other firms include Watermark, Winnipesaukee construction and Northeast Dock and Barge.

I plan to contact some of these firms and see if they can come out and evaluate our beaches and make some recommendations.

6/30/15

I called Environmental Consultants, Folsum Design and Northeast Dock and Barge. I didn't hear back from Environmental Consultants; Northeast Dock and Barge's secretary promised to have someone call me the week of 6th. I spoke with Cynthia Folsum at Folsum Design. She seemed very interested in the project and asked if we had a survey. I agreed to research this issue and call back next week.

7/5/15

I spoke with Bob Shockley at the Board Meeting and he said he had a survey for First Beach which I picked up after the meeting. I also learned from Ron McCracken that the beach in Alton Bay is a perched beach.

The immediate goal is to meet with two or three of the Marine Construction firms in early August during my vacation to get initial thoughts on solutions to the beach problems. I will then report back to the Board at our late August meeting.

Dave Sharp Treasurer's Report

We are also most fortunate to have the volunteer service of CPA Dave Sharp as our Treasurer—Dave doesn't just keep the books he is active in all ways in considerations of dues /asset collections—and the use of those assets to preserve and advance the quality of life for all—and he has led the team in doing so without a dues increase for a number of years. Due to this years projected agenda he has helped us to do some juggling----Dave

Environmental Report –for Jim Minieri----Jim continues to Chair our Environmental team whose responsibility is entered in monitoring –with the help of the appropriate State agencies the health of our central asset, our pond –He will continue to do so in the year ahead –but is unable to be with us today.

ENVIRONMENTAL REPORT

June 6, 2015

Water quality samples from Lower Beech Pond were taken three times by the HV environmental team during 2014, June, July and August.

A 2014 A VLAP Report for Lower Beech Pond from NH DES for the samples taken, including historical water quality trend analysis. Random Weed Watches were conducted on Lower Beech Pond by the Jim Minieri and other concerned members have not found any Exotic Weed Species present.

The Lower Beech Pond HV Environmental Team in 2015 will continue water quality analysis three times during this season, once each June, July and August. There will also be random weed inspections performed during the season.

Not sure if a VLAP Biologist will visit Lower Beech Pond this year or not, I am looking into this matter.

I plan/hope to add Temperature and Dissolved Oxygen Data Collection to the lake sampling this year. Trying to set this up with Sara Steiner VLAP Coordinator

In reviewing accompanying information the only area of concern was the pH that has traditionally been a delicate matter and while listed as the area of concern appears to be stable as it has been in recent years. This area will be receiving particular attention. And all owners are again called on to be sensitive to environmental concerns and guidelines as our pond and its condition are by far our greatest asset and most important guardianship.

Lakes Region Water update -- DMS

David has met recently with owner Tommy Mason and has had renewed contact on related issues with the Directors of DES and PUC. Again while the vast majority of our safety and service concerns have been addressed over the last decade –the central issue of the expense associated with service to Swissvale –not a member of the LRWC group-- remains of significant concern. Questions surrounding its proposed purchase from the Mason Trust of the Mt. Roberts site as well as the associated operating and capital costs –for the fee payments received from Swissvale for water remain –in David's strongly held opinion the current fee seasonal based arrangement w/ Swissvale is fundamentally unfair to the LRWC consumer. In conversation w/ the Director of PUC he has proposed that the contract w/ Swissvale be redrawn so in addition to fees they pay capital costs based on the usage percentage.

It is most important that all parties know that we are paying attention and will react to any level of perceive injustice.

Village District Progress Report re: reconstruction of the earthen Dam
