Jan-Care Feb. 23, 2018 (start of CP program with RGH) jlong@jancare.com
7 pts CHF had a 42% readmission before CP
20% readmission (1 with break through bleeding) (small sample size)
One pt. gained 4 lbs of fluid in two days, CP intervened, lost 2.5 lbs fluid, stayed at home.
12% readmission is what hospital wants

Putman Co. Beginning CP program, data will be coming soon.

A series of C3IFT meetings held to complete a revision of the current C3IFT protocols and accompanying education.

Proposed C3IFT protocols sent to EMSAC members for discussion and possible approval at Mar 13, EMSAC meeting.

23 new or updated C3IFT Protocols

- **Protocol 3101 Volume Expanders**- expanded to allow any blood product and for C3 provider to take 2 bags of blood.
- **Protocol 3110 Burns** was developed and allows for analgesic infusions.
- **Protocol 3201 Chest Pain** treat new onset chest pain, transport for chest pain or newly developed AMI on an IFT.
- **Protocol 3202 Vasodilator** with guidelines to watch for to prevent deterioration of patient while on any vasodilator.
- **Protocol 3203 Antiarrhythmic Drips** changed to enable transport of all antidysrhythmic medications.
- **Protocol 3204 Vasopressor** enable vasopressors to be transported including the levophed sepsis protocol.
- **Protocol 3315 Anticoagulant, 3316 Anticoagulant, 3317 Fibrinolytic** were developed.
- **Protocol 3301 Bronchodilators** guide for what to do on an IFT with either IV or inhaled bronchodilators.
- **Protocol 3308 Obstetrics** guidelines for Mag Sulfate, Fetal Heart Monitoring, Deep Tendon Reflex, and Cl, Gluconate.
- **Protocol 3501 Antivenin** reference added to refer to Protocol 4501 Allergic Reaction. Sheep/horse products added.
- **Protocol 3602 Antibiotics** was changed to reflect the ability to transport more than one antibiotic.
- **Protocol 3602 Neurological** address neuro transfers more than ICP, expanded to support IFT's for Neuro beds.
- **Protocol 3604 Diabetic** was changed to reflect limiting blood sugars below 250 mg/dl.
- **Protocol 3605 Nausea/Vomiting** removed as its contents are now in the scope of practice for EMT Basic.
- **Protocol 3607 PPI** removed all specified medications but still allow provider to transport PPI medications.
- **Protocol 3901 Analgesic** administer pain medications in general and transport analgesic medication infusions.
- **Protocol 3903 was Reversal Removed.**
- **Protocol 3903 Sedation** administration of benzodiazepines for anxiety/agitation and sedation infusions.
- **Protocol 3904 Paralytics** extending ability to transport medications in paralytic category.
- **Protocol 9204** was developed for assessment and procedures for IFTs.

1. Strategic Decision to establish primary 1st goal of beginning implementation of ‘Stop the Bleed’ program in WV.
 - a. Special subcommittee ‘STAKEHOLDERS’ meeting to be March 9, 2018 (see below)
 - b. National Statistical statements
 - i. #1 US Army ranks hemorrhage #1 in the list of preventable causes of battlefield death
 - ii. 3 min. A victim with arterial bleeding can die in as little as 3 minutes
 - iii. 35% Of out-of-hospital deaths are a result of hemorrhaging
 - iv. 80% 80% of mass casualty patients are delivered to medical facilities by non-ambulances
 - v. 140 The number of Active Shooting Events recorded from 2000 – 2015
 - vi. 345 The number of Mass Shootings which occurred in the U.S. in 2017
 - c. Stop the Bleed kits in Schools, Law Enforcement, Public Venues
 - i. Typical Kits include; CAT Tourniquet, Emergency Bandage, Gauze Dressing, Gloves, Instructions.
