Those in attendance reviewed the 2025 collected 2026 proposed budget. A Town levy of \$69,756 is proposed. This is the maximum levy set by the State without a resolution by the Electors. Total 2026 proposed revenues are \$298,545; up 9.4% from last year. Total 2026 proposed expenditures are \$508,901; up 48.9% from last year. This large increase is due to proposed road construction on Stilen Road this year. \$45,000 will be dispersed from the Fire Equipment Reserve along with the American Rescue Plan Reserves of \$64,718 to pay toward Maple Creek's portion of the Village of Bear Creek's new fire engine. Also, \$9,998 will be dispersed from the Environmental Impact Reserves to balance this budget. Total reserves last year were \$374,644 and this year's proposed is \$259,928. Those in attendance did not propose any changes to the budget.
