- 1. This agreement is for STORAGE ONLY, the space to be used at the sole risk of the owner. Vessel owner agrees to carry full insurance at all times, with minimum liability insurance of \$300,000. Vessel owner hereby assumes total responsibility for casualty or other loss and waives subrogation rights of any of its insurance carriers. Harbor Country Marine is not responsible for boat content, or equipment. Please remove or secure any valuable possessions. Harbor Country Marine will not assume any liability for torn or damaged canvas while in storage.
- 2. Owner agrees in case of emergency that boat may be moved from storage space.
- 3. Owner agrees to comply with all posted rules and regulations. No refinishing work or repair work will be allowed inside the storage buildings. No flammable materials are allowed inside the storage buildings at any time. Smoking on all of our premises is strictly prohibited. Exceptions must be arranged with our management.
- 4. Boats being removed from storage shall require an order from the owner at least two weeks in advance, and are scheduled on a first come first serve basis. Extra fees could be incurred for delayed launch. In the event that the vessel/vehicle is not removed from storage, this agreement will continue to be and that rates and schedules of charges in effect at any future dates will be applied.
- 5. All charges must be paid before vessel is removed from yard and prior to launch. The owner hereby agrees that all charges pursuant to this agreement or for other services otherwise rendered by Harbor Country Marine at the request of the owner and which remain unpaid shall constitute a lien on the owner's boat per the Michigan Marina and Boatyard Storage Lien Act Public Act 362 of 1998.
- 6. Haul-out is scheduled on a first come, first serve basis. Vessel owner assumes all responsibility for freezing conditions while boat is left in the water or storage, unless winterized by Harbor Country Marine.
- 7. Harbor Country Marine reserves the right to pull out of storage and/or launch any boat by April 1.
- 8. Any outside hired labor must check in with the management at Harbor Country Marine with proof of adequate insurance and workman's comp insurance.
