RESOLUTION NO: SL –38 – 2024

TITLE: Approval of Vendor to Purchase New Cargo Van

WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and,

WHEREAS, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and,

WHEREAS, on March 11, 2021, the President signed the American Rescue Plan Act of 2021 (ARPA) (Public Law 117-2), which invests \$1.75 billion in American Indian and Alaska Native government programs administered under the oversight of the Department of the Interior's Assistant Secretary – Indian Affairs (AS-IA); and,

WHEREAS, Summit Lake Paiute Tribe was awarded funding to aid tribal government services, public safety and justice, social services, food, child welfare assistance, and other related expenses; and,

WHEREAS, Summit Lake Paiute Tribe has created a Food Pantry to help fight hunger within our tribal membership based off of donations, grants, and ARPA funds; and,

WHEREAS, Summit Lake Paiute Council received \$713,259 of Nevada Indian Commission (NIC) subgrant ARPA Funds (APER Fund Code 257; \$58,712 allocated for vehicle) to purchase a cargo van to aid Food Pantry staff with picking up donated and purchased food and supplies; and,

WHEREAS, per the Tribe's Procurement Policy, the Food Pantry Department has obtained quotes for the necessary equipment; and,

WHEREAS, the Food Pantry Leads have provided these quotes and recommendation to the Summit Lake Paiute Tribe Council for approval; and,

WHEREAS, the Food Pantry Department is requesting to purchase a 2024 Ford Transit 250 MR Cargo AWD for the total price \$58,302.75, which includes license and fees, delivery fee, and documentary fee; and,


