Our goal is to provide a clean, sanitary trip making all reasonable efforts to minimize transmission of COVID 19 to our clients.

- **PLEASE STAY HOME AND CANCEL YOUR GUIDED TRIP IF YOU:**
 - Have experienced any cold/flu or COVID-19 symptoms within the past 2 weeks (especially fever, cough & loss of smell/taste)
 - Have been around anyone else who has exhibited cold/flu symptoms, or was known to have COVID-19 in the past two weeks
 - Have a temperature of 100 degrees or more
 - If you or anyone else you have been around in the past 2 weeks has had a positive test for COVID 19
 - Please contact us 24 hours before your scheduled trip to update us if any of your symptoms or history has changed
- We ask that you wash your hands and use the restroom and fill up your gas before meeting us at our designated location.
- A meeting place and time away from launch ramp and docks will be confirmed prior to your trip, to help manage distancing at boating facilities.
- We will do our best to maximize space between individuals during the trip and minimize indoor cabin time together.
- We will provide individual boxed food/drink professionally prepared with access to hand sanitizer throughout the trip.

PLEASE READ CAREFULLY BEFORE BOOKING YOUR TRIP; THIS IS A RELEASE OF LIABILITY AND A WAIVER OF CERTAIN LEGAL RIGHTS. Although strict measures are being taken by Just Add Water Fly Fishing LLC to prevent the spread of COVID-19, the undersigned acknowledges that participating in these activities with Just Add Water Fly Fishing LLC could result in COVID-19 infection. By accepting the charges for your trip, you agree to this release & waiver in consideration for being permitted to participate in the activities coordinated with Dan Anthon's Just Add Water Fly Fishing LLC.

I agree to the following waiver and release: I acknowledge that fishing/boating/hiking has inherent risks, hazards, and dangers for anyone that cannot be eliminated, particularly in a wilderness environment. I understand that these risks, hazards, and dangers include without limitation: 1. Water hazards in boating and wading in the rivers including drowning; 2. Hiking in rugged country; 3. Injuries from fishing equipment and other participants; 4. Encounters with wildlife, animals, and insects; 5. Temperature extremes; 6. Inclement weather conditions and unavailability of immediate medical attention in the wilderness in case of injury 7. Possible COVID-19 infection.

I understand the risks, hazards, and dangers of fishing and have had the opportunity to discuss them with my guide and outfitter. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I am voluntarily using the services of this outfitter/guide with full knowledge of the inherent risks, hazards, and dangers involved and hereby assume and accept any and all risks of COVID 19 infection, injury, paralysis, or death.

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby knowingly and intentionally waive and release, indemnify and hold harmless my assigned guide and outfitting company, their directors, officers, agents, contractors, employees and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, negligence of any kind or nature, whether foreseen or unforeseen, arising indirectly or directly out of any damage, loss, injury, paralysis, COVID-19 infection or death to me or my property as a result of my engaging in these activities or the use of these services, animals, or equipment, whether such damage, loss, injury paralysis, or death results from negligence of my chosen/assigned guide/outfitter, or from some other cause. I, for myself, my heirs, my successors, executors and subrogates, further agree not to sue any entity, business, employee, guide, volunteer or outfitter associated with my activity/trip. Injury, paralysis, or death suffered in connection with my use and participation in the activities of this outfitter/guide/company is solely my responsibility.
