Community Reminders

Parking: It has been noted that quite a few residents are parking on the street overnight. As per our Rules and Regulations no parking on the street overnight is allowed from 2:00 am to 6:00 am.

Vendors staying late: Security continues to report that we have vendors staying over allotted hours. Our vendor hours in summer are from 7:00 am till 6:00 pm and our winter hours are 7:00 am to 5:00 pm. Please remind your vendors of these hours.

Side Walls: Some side walls bordering our properties need attention so please take time to look and have them repaired and painted if needed.

Garbage Bins: Trash bins may be placed at the street for collection 12 hours before pick up and empty cans must be removed from the street no later than 12 hours after pick up.

Once bins have been removed from the street after pick up, they must be placed out of sight from the street view and adjacent lots.

Palm Trees: A friendly reminder that by August 1 homeowners should have had their palm trees trimmed, cleaned and seeds removed, or a violation letter will be sent.

Parking Over Sidewalks

Some residents are parking their cars over the sidewalks, when parking in their driveways which prevents our residents from walking on the sidewalks. Please be courteous and park your car in your driveway so the pathway is left free. Also, please trim bushes away from the sidewalks.

Grass Areas On La Mesa

The Board was sent via the HOA a news an article from Fox 5. The community might want to start thinking about looking into getting quotes to replace the grass on the two out lets on La Mesa; the front gate entrance, the corner of La Mesa and Warm Springs, and the grass area at the bottom of La mesa at the wash.

A drought tolerant landscape or faux grass, is what they suggest we go to by 2027. We have time, but it should be discussed at a future Board meeting.

LAS VEGAS (FOX5)—Nevada Governor Steve Sisolak on Saturday signed into law Assembly Bill 356, which requires the replacement of unused grass landscape.

According to a news release the Southern Nevada Water Authority, Assembly Bill 356 prohibits the use of Colorado River water delivered by SNWA member agencies from being used to irrigate non - functional grass by 2027." The release notes that this requires the replacement of non-functional grass – decorative grass in streetscapes, medians, parking lots and other areas where it is used for aesthetics and not recreational purposes- by December 31, 2026.

Pine Trees

We are sure you are all aware that we had a pine tree at the club house that had a broken branch which was the result of a storm. It has finally been removed along with a small pine behind as it was seriously leaning. We also had to take out a pine tree on Pecos as it had turned brown due to being diseased . We will be also taking out two pines on Pecos. One is leaning towards Pecos which could be serious if it falls on the road or maybe a car and another one which is leaning up against the wall and could do serious damage to the wall.

The trees on Pecos will not be replaced due to the small area between the sidewalk and our wall, the Landscape committee will make a recommendation to the Board as what if anything to be planted there,

Accident On Pecos

On July 1st a car ran into the wall at the corner of Pecos and Warm Springs and landed in the back yard of 57 Quail Run.

A police report was filed, and pictures taken. All walls are on the property line and the walls are the responsibility of the homeowner to repair. If walls are shared by homeowners and these walls are damaged, the repairs are the homeowners and should be discussed between homeowners





Driveways

It has been noted by our management company on monthly inspections that some residents, have cracked and lifting driveways which are dangerous, and which also looks bad and unkept. Please inspect your driveway and have them repaired or replaced so that a violation notice does not have to be sent

DID YOU KNOW there is a right and a wrong way to drain a pool?

Water drained from a hot tub should be drained directly into the sewer clean-out port located on your property so the water can be properly treated and recycled back to Lake Mead. Pool water should **NEVER** be drained into the street or gutter since that water cannot be collected and recycled. It could also result in a violation of the City municipal code and possible fines.
