- 4. Lady Heton Action Group Peter Morgan informs MTC of the flaw in BE12 policy he confirms that Kirklees Internal Guidance document is not a clarification but a fundamental change that impacts on both existing residents and new residents and is looking to MTC for full support. Cllr Lees-Hamilton asks Cllr Harding & Cllr Nottingham who were absent from last meeting if they will support LHAG. Both Cllrs agree they will support this. Cllr Lees-Hamilton states that if BE12 is left as is, a terracing effect may happen Cllr Pinder Proposed MTC inform Kirklees that it condemns the doubt surrounding the BE12 clarification and after closer examination it appears BE12 in the Internal Guidance Document is a material amendment and MTC demands that this document is rescinded forthwith Cllr Lees-Hamilton Seconded **Vote:** All in favour Peter Morgan confirms his appreciation for the backing from MTC with this and other builds Cllr Lees-Hamilton states MTC are happy to back this an states it has been a pleasure working with LHAG who have been proactive and diligent. LHAG leave at 8.10pm.

- 1. Mirfield Public Toilets Cllr Lees-Hamilton reads an email sent from CIIr Bolt regarding the payment of the Cleaning Invoices she also confirms that the toilets were not cleaned on 4th, 6th, 7th & 8th March to her knowledge and the disabled toilet has still not been cleaned. She also states that additional keys need cutting. Cllr Nottingham asks about possible graffiti and Cllr Lees-Hamilton states she has had a conversation with Churches Together Outreach Worker regarding a 'Mural' of Graffiti Art in the toilets and that they are very interested. She states that although the cleaning has been inappropriate MTC has allowed it to continue. Cllr Pinder Proposed MTC welcome Cllr Bolt's initiative and that Cllr Bolt pursue this with all despatch Cllr Lees-Hamilton Seconded Vote: All in favour. Cllr Pinder confirms that the padlocks for the Ladies Toilets need replacing. Cllr Lees-Hamilton **Proposed** MTC authorise Cllr Pinder to get estimates for padlocks and proceed with the cutting of additional keys and to instruct Elaine Ellis to cease cleaning and Tracy at Well Polished to commence Cllr White Seconded Vote: All in favour Administrator confirms that the invoice for 2014/2015 Business Rates has arrived and is for
- 2. Hanging Baskets Defer until Cllr K Taylor present
- Health & Safety Paperboys/Girls No response from H & S Executive item deferred
- 4. Donal O'Driscol Mirfield Music Festival Donal gives MTC a brief outline of past events he has organised. He confirms that he has lots of bands lined up for Mirfield and would like Brian Robinson to open with the link of the Tour De France. He confirms that he has applied for a Premises Licence from 12.00 noon - 10.30pm Sunday 25th May. He confirms it will be both a 'Family' Festival and well stewarded and that Kirklees Hospice will be the beneficiary charity. He states that ticket sales have been slow to start but picking up, he confirms that he needs to turnover £36k in total, but hopes much of this will be in sales of alcohol and soft drinks. Cllr Pinder asks about the licence. Donal informs MTC that the licence will be from Friday-Sunday, but only intends to sell alcohol during the hours he has mentioned and that there will be a team of cleaners for the end and bin liners available during the festival. Cllrs ask if there will be a police presence and road safety i.e. people congregating by the wall. Donal states he will be informing the police but as it is stewarded, would not expect a police presence. He also confirms that the fair rides and children's activities will line the perimeter wall, so this will obscure viewing from the roadside. Cllr Lees-Hamilton comments that this is well thought out and will be a good event for Families and the young people of Mirfield and thanks Donal for his presentation. Donal leaves.at 8.00pm
