I Call to Order by Chair Bonjour & Welcome to New LG Members

Bonjour called the meeting to order at 11:04 pm. A quorum of the board was present. All attendees introduced themselves to one another.

II Action on Agenda

Daggett moved and Williamson seconded approval of the agenda. Approved unanimously.

III Appointment of NE Regional Leadership Group Representative

Buckton shared that Nick Trenkamp of Central CSD & Eastern Allamakee CSD and NE Regional Representative, has submitted his resignation from the RSAI Leadership Group. Buckton also shared the staff recommendation to appoint Barb Schwamman of Osage CSD & Riceville CSD to fill his remaining term due to her experience serving many years on the RSAI Legislative Committee. Discussion ensued. Motion was made by Hissem to appoint Barb Schwamman as the new NE Regional Representative through Oct 2027. Seconded by Williamson. No additional nominations were brought forth. Approved unanimously.

With the resignation of Trenkamp, RSAI has a vacancy in the officer role of Secretary/Treasurer. Buckton reviewed the responsibilities of the position. Hissem offered to serve. Lorenz moved to elect Hissem as Secretary/Treasurer for the remainder of the term ending Oct 2025. Second by Williamson. No additional nominations were brought forth. Approved unanimously.

Buckton reviewed the list of legislative committee members and remaining vacancies, a reminder to complete the legislative issues survey circulated to members, and reviewed the plans for the committee meeting on August 14th. Discussion ensued. Schwamman moved the appointment of Erik Smith of New Hampton CSD and Turkey Valley CSD to represent Keystone AEA in the NE Region on the Legislative Committee, and to direct staff to fill the vacancy for Grant Wood AEA in the NE Region for ratifying at the August Leadership Group Meeting. Second by Hissem. Approved unanimously.

Buckton shared an overview of the purpose of the Bylaws Committee and indicated a meeting date would be shared very soon.

Buckton and Daughton discussed the DE Report to the Field circulated recently, the RSAI Call to Action on Federal Funds and contact information, and the group discussed issues around property taxes.

Buckton and Albers shared that the Spring 2025 reimbursement request has been submitted on behalf of the Cherokee Consortium and that WGU was working on pulling together information and possible resources for participants who will not have

finished their teaching degree by the time the TPRA 1.0 grant program concluded on 12/31/2025. Discussion ensued.
