Presiding Commissioner, Kyle Carroll, West District Commissioner, Kyle White, East District Commissioner, Garry McFee and County Clerk, Melissa Meek.

Presiding Commissioner, Kyle Carroll, West District Commissioner, Kyle White and East District Commissioner, Garry McFee welcomed those in attendance with Kyle Carroll leading the group in prayer followed by the reciting of the Pledge of Allegiance.

The minutes of the April 28, 2020 meeting were read with West District Commissioner, Kyle White making the motion to approve. East District Commissioner, Garry McFee made the second. Motion carried.

Chet Owen was in attendance for today's meeting.

East District Commissioner, Garry McFee had a Extension Meeting via ZOOM on Monday April 27th.

West District Commissioner, Kyle White and Presiding Commissioner, Kyle Carroll attended a meeting with Tri-County Health on Thursday April 30th.

The Patterson Foundation donated masks to DeKalb County and will be available for Election Judges.

The Commission discussed the CARES ACT FUNDS that County is expected to receive. More information will be gathered before any funds will be distributed.

Jim Shrimpton, City of Cameron Accountant called the Commission to discuss how the CARES ACT FUNDS would be handled and distributed. The Commission advised that the funds had not been received yet and that the County was waiting on more direction from the State on how to handle and disburse.

Road & Bridge Supervisor, Bill Gray met with the Commission to discuss purchasing a new mini excavator, putting old equipment out for bid, work his department was doing, equipment repairs and a patrons concern over a culvert. The Commission advised Bill to get with each vendor wishing to sell the County equipment and see if they will let him run the machine to determine which one was the best suited for our County. No bids will be sent out until late fall per Commission dependent upon revenue.

County Clerk, Melissa Meek continues to keep the Commission updated on sales tax revenues.

Staffing has for the most part returned to normal as of May 4. Patrons entering the building will continue to follow the guidelines set forth by 43rd Circuit Judge Brent Elliott. Those guidelines include answering a questionnaire and signing in. Office holders may allow only 1 or 2 patrons in their offices at a time please make sure you call before coming to the Courthouse as some of the things you might need to take care could possibly be taken care of by phone, mail or email. The Commission continues to thank all of the patrons in the County for their patience and understanding during this unprecedented event that has affected our entire nation.
