Mayor Edwardes called the meeting to order at 6:00 p m, he then led the invocation and Pledge of Allegiance.

TITLE: AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE TOWN OF GREENWOOD, BY REZONING PROPERTY IN THE VACINITY OF THE 9100 BLOCK OF GREENWOOD RD, MORE PARTICULARLY DESCRIBED IN EXHIBIT “A” TO THE ORDINANCE, FROM R-A RESIDENCE/AGRICULTURE DISTRICT TO B-1 BUFFER BUSINESS DISTRICT AND OTHERWISE PROVIDING WITH RESPECT THERETO (Final passage))
