BID OPENING FOR THE BLANKETING OF 5½ ACRES AND AN ALTERNATE
BID OF 2 ACRES OF KEN'S LAKE-----November 1, 1982

The meeting was called to order by Chairman K.E. Mc-Dougald at the District's Office at 1:05 P.M. with the following Board Members present: Everett Schumaker and Sam Taylor.

All the bids were read by Brad Price. Brad Price stated that an abstract of all bids would be mailed to all bidders. Brad Price and the Board Members talked with Lawnie Mayhew of Harper Excavating, Inc. to discuss the details of the project. Brad Price stated that there were 2 things that are essence on this job. They are: Time---The deadline for the project is December 20th, 1982 anticipating that the contractor has to move 2,000 yards of material per day. Jim Boulden stated that the washing down of the bedrock should be completed by the end of the week.

Brad Price stated that if the contract can not be awarded by November 5th, 1982, we will extend the date of completion. On the 5th of November, we will evaluate if we can have a contractor on the job. If we have to delay the starting of the blanketing of the 5½ acres, the completion date will be extended by a comparable calendar day basis with the exception of bad weather after December 20th, 1982, those days would not be counted in the contract. Brad Price stated that there is a liquidation damage clause for \$500.00 per day. Brad



Price told Mr. Lawnie Mayhew from Harper Excavating Inc. that he and Everett Schumaker and K.E. McDougald discussed prior to the bid opening, that if Harper Excavating Inc's bid was the lowest and this company bid without seeing the proposed project, that Mr. Mayhew may go and look at the project, he cannot change his bid, but may withdraw his bid after looking at the project. Brad Price stated to Mr. Mayhew that he understand that the line and volume quantities will be based on compacted fill basis. Brad Price also stated that Mr. Mayhew will be responsible for the moistening condition of the clay and the sprinkler system during the period that you are working on this project.

Mr. Mayhew gave a brief statement about his company. He will send a financial statement, what his company consist of, how long his company has been in business, etc. within 5 days.

The meeting was adjourned at 2:15 P.M.
