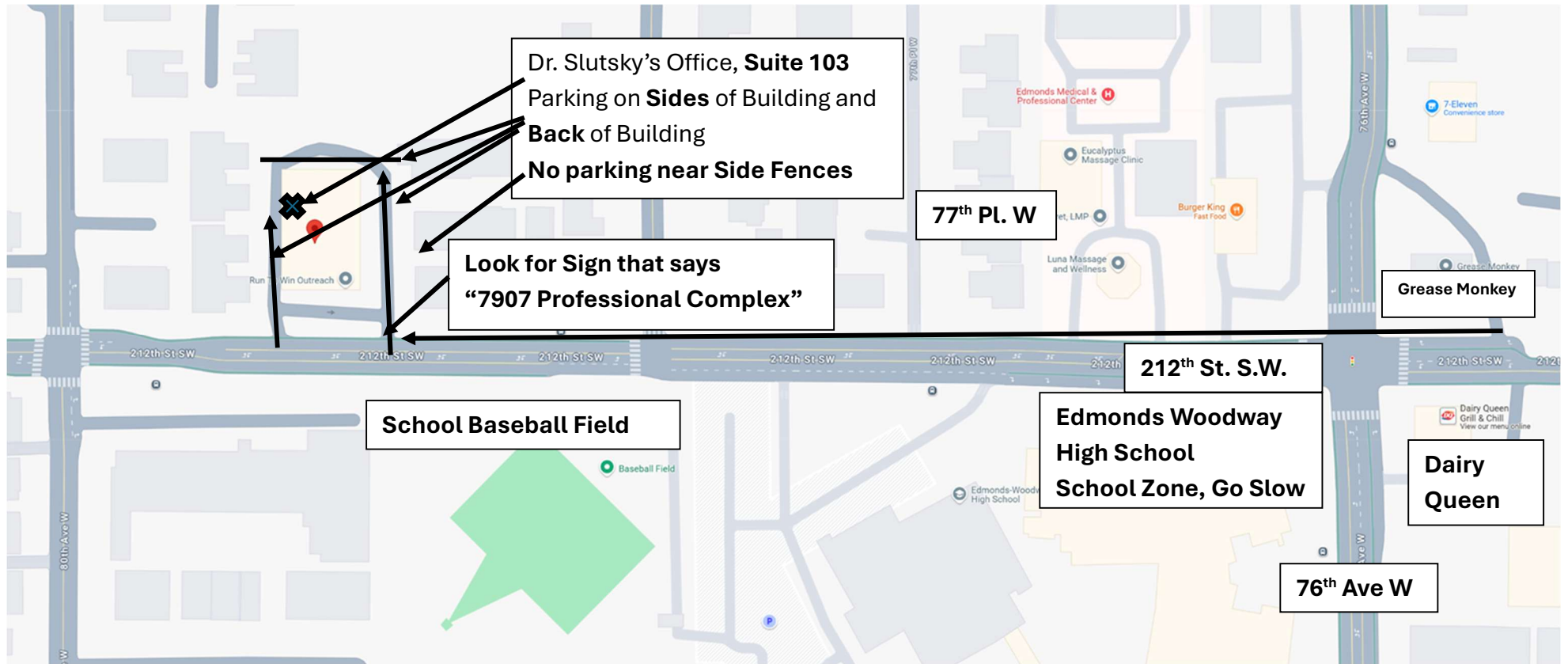

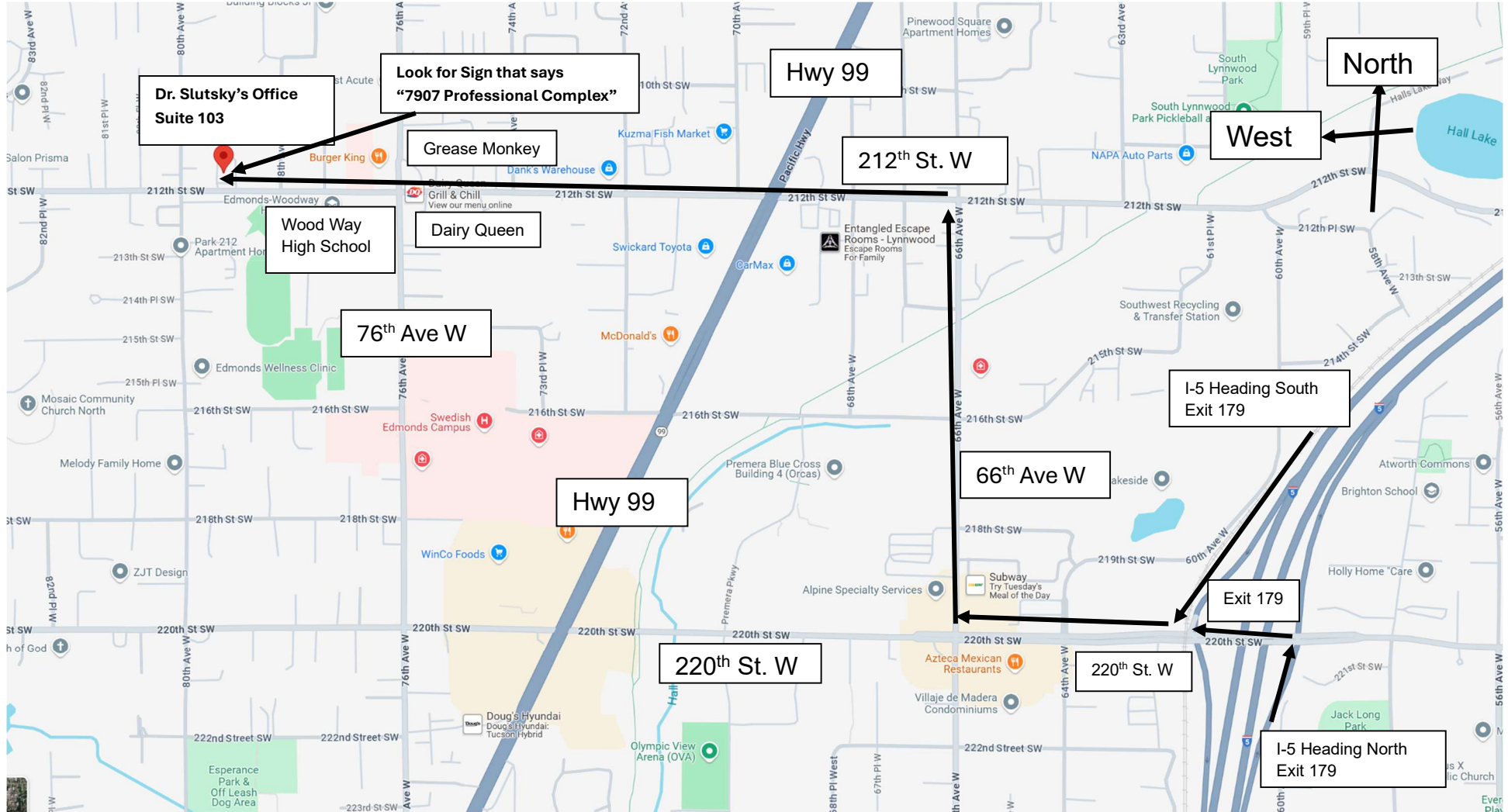
- **Head Southeast on WA-104 E toward Ferry Terminal Lanes**

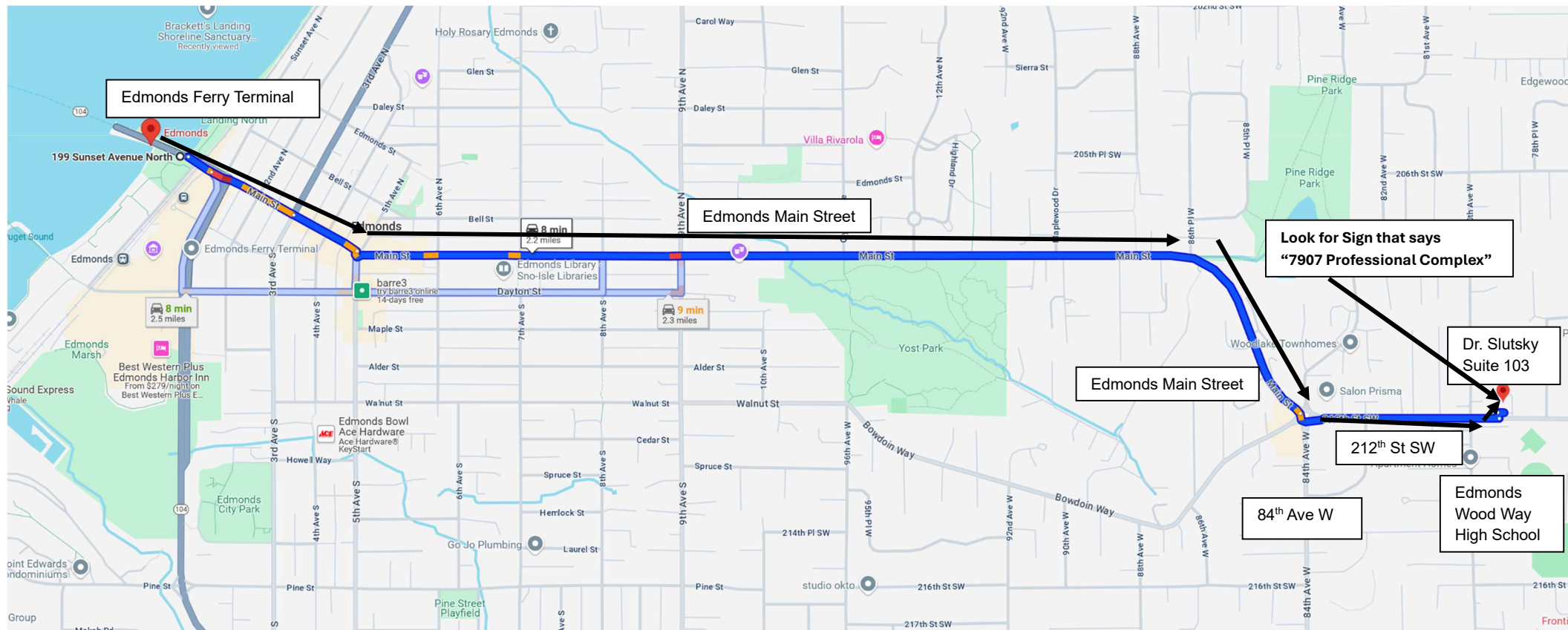

**GENERAL OFFICE POLICIES**

Dear Patients,

Please be aware of Dr. Slutsky's Policies (below)

- A. **Face Covering** is optional. It is not required.
- B. In all but **Rare** circumstances (which must be pre-approved by Dr. Slutsky), only the patient is allowed into the appointment with Doctor.
- C. When you arrive at the Building, please **Wait in Your Car**. **Dr. Slutsky will call you on your Cell Phone when it's safe to enter the premises.**
- D. Those **who don't have a Cell Phone**, can only come into the Building **exactly at their Appointment Time**.
- E. Maps, Directions, Contact information, Policies may be obtained at [www.hearexams.com](http://www.hearexams.com).
- F. **No Guns** are allowed in Dr. Slutsky's office.
- G. **No Animals are allowed** in Dr. Slutsky's office. The only exception is a **Certified Service Animals** however you must be pre-approved by Dr. Slutsky.
- H. **Small Children, Babies who are not able to sit quietly** may not be brought into my office for the appointment as we will not be able to perform a valid Hearing Test.
- I. Patients must have **14 hours of Low or No Noise Exposure prior to their appointment**. Otherwise a valid Hearing test cannot be performed
