Davis – So Larry asked me, Larry is our Treasurer and he asked me to transfer some money out of the streets restricted fund for 2023, 2024 and 2025, which I don't believe we can legally do because that has been closed out. It's been audited and been approved, that budget has been approved. So, before I did that, I would like the Board's approval or tell me not to, whatever you guys want to do. Also today he asked me to transfer money from capital improvements, close to \$23,000 but the General Fund still owes \$60,000 to the Capital Improvements fund.

Petty – So, for the prior year, streets I think those budgets have passed, I don't want to, I don't think it would be good practice, especially because we've already been audited for those years, to change how it moves.

Davis - Right.

Petty – Moving forward, it has been standard practice, it's all cash in one fund, the City, because of how the money comes into the account through taxes, it builds up and depletes, builds up then depletes. Because of that, the capital improvements fund is used as kind of a loan within the City's own finance account so when the city's operating fund gets low, we use the capital improvements fund as our operating budget and as our funds come in through the taxes, then we are able to move the money back into the capital improvements fund to the operating budget. So that has been something that this Board has approved for many, many years and Sara is letting us know that we do still have an outstanding debt within our own cash accounts to make sure that we balance that appropriately. I think as long as we, and what this Board has done, when we

accept budgets, we make the statement that we do intend over the next year to be even as far as where we are with the operating budget and what's due to the capital improvements budget and those will be balanced or we will make every effort to make sure that those are balanced by the end of this fiscal year.

Davis – The current one we're in or the one coming up?

Stewart - Yep, I agree.

Hodges – I have a question. The bond money. Does it go into the general fund or where does it go?

Petty – The bond money is basically a loan that will get deposited into the city account that we will then use for the projects that the city approved that we use them on specific to the wastewater treatment plant and stormwater drainage.

Dr. Edward Walton – Good evening. Thank you for allowing me to speak. I am the Executive Director of the Springfield-Greene County Library and a 22 year resident of Fair Grove. So, I've been here for a long time. In our strategic planning process, we took a look at a master planning schedule that we're developing over the next year and in that schedule is to build 3 branch libraries. One here in Fair Grove and two in Springfield and the outside edges of the city. All of that is contingent upon funding. So right now we're in a project where we just spent \$24M to build the Midtown Carnegie Branch which is downtown, to build an auditorium Building C, which is the southside of Springfield and build a brand new building in Republic. That's \$24M total so we're at a point where we've expended the capacity for us to build right now. In our strategic plan, we anticipate in year two of the plan, so 26, 27, that we will begin funding or seeking funding to build a Fair Grove library. We will be in the planning phase in 26 or 27 which means that we will probably be building in the 27-28 budget here in Fair Grove.

Petty – So we probably don't need to have this discussion for a couple of years is what I'm hearing.

Dr. Walton – A couple of years.

Petty - Okay.

Austin – I do have it on my calendar to submit the request for two additional years on our current lease.

Petty – Okay. Does that require any approval or discussion by the Board on approving moving forward with requesting a two year lease?

Austin – I have a copy of our lease. It's just written in there that as long as we give 90-days notice and we've been good tenants, we can request a two-year extension.

Dr. Walton – No. I'm sorry that is incorrect. The wording of this lease is that we have an option to request a two -year extension in December of 25 and we have an option for a one-year renewal for a 2-year lease. So in December of 27, this contract expires.

Austin – Yes. Sorry, I was not being...

Austin – ...that specific. We have one chance basically, one additional two year extension and then we'll have to discuss...

Dr. Walton – No, that's not the way that the contract reads. The contract reads that our original lease ends in December of 25...

Chief Riggin – Alright, not a ton either but a couple of things. My commitment for training, which answers the question, can we do police work. When you guys hired me, that was number one. Can we do police work? Sgt. Deckard is right now, currently, this week, at a major crime investigation class. That's what we would call it. Drury calls it something else and she's just getting inundated with great ideas and thoughts. Office Brian Long is attending Midwest Tactical Law Enforcement instructor course so that will give us a firearms instructor for shotgun, rifle and handgun. It's not that I don't like relying on the help of Greene County and others but now we will be in a position to help when they are short or whatnot. I spent time with the new chief of Bolivar, the city of Bolivar, he's a friend of mine and we were even talking collaboration and what that looks like for us and them as well. So we've got Sgt. Deckard in training, Officer Long in training and then I will be attending the FBI Central States Law Enforcement Executive Development seminar. That's in September. That is by invitation only. So, I applied for it, you have to have references and such and I was accepted so I will be heading to the FBI training in Lawrence, Kansas. That is a three-part training, you don't have to attend the other two but once you attend this one, you will be invited to the other two. So that's important because there again, if you want your Chief's to be doing what they should be doing, I've been looking at the news and all of the indited chiefs and fire chiefs and a lot of times it really is that they just don't know what they're doing and we want to make sure that is not the case in Fair Grove and it won't be. Recruiting, I've been getting a ton of wholly unqualified officers but I have at least two that I am currently looking at. I will work short before I work wrong and I have at least two that I'm looking at. I have a reserve, probably once I get her background back we will move forward with bringing her on as a reserve. 17 year veteran with the Greene County Sheriff's Department, she just wants to give back to her community because she lives here. Lastly, your crosswalk project

that you gave me, we had MoDot come out and do a speeds study. We did one a few weeks ago and we're going to do another one in September when school starts. The engineer, it was very simple, his email said this "you guys are wildly compliant on that stretch of Old Mill". The speed limit is 35, their average after about 3,000 or 4,000 cars registered, their average in the 80%, which is their average for engineers, was 37. The crosswalks look great to them. It's built to their standards which is built to federal standards. So, we're still looking at moving forward with that and if there are any issues, we will find them. I think it's educational. We have to teach people what that means. Currently there is no law that says you have to stop when someone comes up to the crosswalk, they only have to stop when they're in the crosswalk on their side of the street. That's what your ordinance says here and that mirrors state law as well. Springfield is one of the only cities I know that has a 3 foot rule and it's only at uncontrolled intersections. What it's going to be is that the SRO at the school, I'm going to hook up with him when school comes up and say you need to educate your kids not to run across the crosswalk. Currently the track country team runs across Old Mill every single day, not in a crosswalk and they violate about 20 different laws. It's not the motorist I'm concerned about. They're doing their part. 37 average in 35 is remarkably and wildly compliant. I think we need to train the pedestrians. That's all I've got unless you've got questions.

Petty – No, I think that's fantastic. We asked you to do this two meetings ago and you've produced real tangible evidence...

Riggin – And we're not even done.

Petty - ...and we're not even done yet.

Riggin – Cause you're going to want to know what it looks like when school comes around.

Petty – Absolutely.

Riggin – It could be a totally different situation.

Petty – I think it's fantastic. I think it's a really good highlight of the caliber of Chief that we have here in Fair Grove and just appreciate you. Thank you for doing that. It means a lot to the residents to know.

Riggin – Yeah, no problem.

Stewart – Congratulations on being accepted into that training. It's a big deal.

Petty – Yeah. By invitation only.

Riggin – There were two of us in Southwest Missouri. Me and Joe Mahan who is the Chief of Walnut Grove, has tried for 7 years, so it's taken him a couple of tries.

But they had a great suggestion and we need to either find somebody that's qualified to help run the sewer plant or find somebody that wants to work here for the sewer or be trained on the sewer and will mow and will do whatever Kennie says because if we don't, we're going to be in trouble. But she had a good suggestion for us and we need to hurry up and find somebody or do something. There's a class in October DNR's putting on in Springfield. \$300 bucks. It's an intermediate class to get you help to run the sewer plant. If we don't get somebody by then, we're gonna have a big problem cause the next class is 3 hours away that someone would have to go. I recommended for us to start looking to find somebody that can work for the City of Fair Grove that can do the mowing and get qualified to run the sewer plant. I feel sorry for this town. *inaudible* But I'm just bringing it to the Board *inaudible* and I don't know what DNR would say that we have somebody running the sewer plant that's not qualified.

Petty – So, several meetings ago, this Board approved putting out for a part time employee. Right now it's seasonal with the opportunity to expand that position to train and be under Kennie's tutelage for the sewer department. We just approved the budget for FY26 and that position is included in it. So, absolutely agree, Franklin and we have already started the process of getting that position posted. We have a job description and Mark and I have reviewed it.
