## **oasis pools add \$750 plus approximately \$3000 for semi inground**

- Where more than 6" of leveling is needed the following charges apply: 12'-24' (\$25/in), 27'-33' (\$30/in). Note: Leveling of site does not include removal of tree roots, buried pipes, concrete, debris, large rocks , stumps. Extra fees will be assessed by installer.
- Existing decks require more work. Extra charges will be assessed by the installer
- Travel charges as follows: Twenty miles from Harmony rd norfolk va a \$7.00 per mile fee will be added to your bill
- Substitution of factory hoses to flexible pvc including shut of valves \$300
- Service calls and estimates \$100 plus milage

### **CUSTOMER SHALL OBTAIN ALL BUILDING PERMITS**

#### **Responsibility of customer to include the following**

- Customer is responsible to obtain any and all permits that are required
- Customer is to have a licenced electrician to do all electrical work to pool including grounding
- Customer is solely responsible for placement of pool
- Customer takes full responsibility for all safety issues and liability from owning a pool
- Pool and sand must be delivered prior to installation date
- Customer must provide a seven foot access for heavy equipment

- Sod, dirt, or garbage removal from property
- Any damage caused by access or egress to pool site. Including but not limited to lawns, driveways, sidewalks, sod, sprinklers, flowers, or patios
- Water or utility costs for pool set up repair and or replacement
- Damage sustained to the pool and its components due to manufacture defects, failures caused by customer neglecting to follow post assembly instructions, sand washouts or impressions in sand bottom, ground settling and or damage/failures reflective of any and all acts of nature. Including moles or nut grass
- Pool liners, water, chemicals, labor due to manufacturer defects
- Landscaping or backfilling pool
- Any and all electrical work
- Installing ladders for pool
