

ORDINANCE NO. 2009-4

**AN ORDINANCE AMENDING ORDINANCE NO. 93-1 AND PROVIDING  
COMPENSATION FOR CERTAIN VILLAGE OFFICERS FOR THE VILLAGE OF  
CHAPIN, MORGAN COUNTY, ILLINOIS**

**BE IT ORDAINED**, by the President and Board of Trustees of the Village of Chapin,  
Morgan County, Illinois as follows:

Section 1: Ordinance No. 93-1 entitled *An Ordinance providing for salaries of certain Village Officials and Employees for fiscal year commencing on May 1, 1993 and ending on April 30, 1994*, is amended effective April 5, 2011, as set forth herein.

Section 2: Effective April 5, 2011, the compensation to be paid to the President, Clerk, and Trustees, shall be as follows:

President	\$3,000.00 per annum
Clerk	\$1,500.00 per annum
Trustees	\$60.00 per trustee for each meeting attended

Section 3: The compensation provided for in Section 2 above shall be applicable to the President, Clerk, and Trustees appointed or elected to the respective offices on or after April 5, 2011.

Section 4: All ordinances and resolutions in conflict herewith are hereby modified or repealed to the extent the same are in conflict with this ordinance.

Section 5: This ordinance shall be in full force and effect from and after it's passage, approval, and publication in pamphlet form as provided by law.




