## **Committee Reports**

<u>Fish & Wildlife Management</u> – Trapping Results: 4 beavers this season – Martha asked if there was any information about the possible fish kill that the DNR mentioned was possible this year. No one had anything to report.

<u>Lake Improvement Report</u> – Treatment notice needs to be to property owners 2 weeks before the treatment happens. Discussion on what that will mean for the newsletter.

Sandy moved that the treatment notice be circulated by PLM rather than TLA this year. Dave 2<sup>nd</sup> Passed Martha and Dave are furthering education on Lake Quality Testing. Myle has completed her training. Dave presented CLMP Reports – Long terms trends largely unchanged. Discussion on factors at play. Dave shared that it's important that we have several people trained and experienced in the monitoring.

# Ad Hoc:

Mike shared that the RV Park Committee worked through the winter as an entity to address the proposed RV Park. There was a lot of interest from community members outside the TLA. So, the committee decided to create a new and separate entity including others in the township. Morton Township Residents for Responsible Development (MTRFRD). They have their own website and functional movement.

Mike asked that we support this new entity in whatever ways we can.
