Lauderdale Isles Community Center Update By Earl Prizlee

LICIA continues to make progress on the development of the new Lauderdale Isles Community Center. If you're new to this initiative, here's a quick recap: The former Yacht Club, originally built as part of the Lauderdale Isles development, was re-

cently sold to a private owner. The City had set aside funding from the Parks Bond for its purchase, but rather than losing those funds, the City Commission has agreed to allocate them toward constructing a new Community Center at Lauderdale Isles Landing, a City-owned site in the same vicinity.

To bring this vision to life, the City has engaged AECOM to design and develop construction plans. LICIA Board Members have already held several meetings to outline conceptual designs, and now we want to hear from you!

AECOM and City staff will present preliminary plans at the next LICIA General Membership Meeting on March 20, 2024, at 7:00 PM. This is your chance to provide input before the final design moves into the permitting phase. We encourage all residents to attend and participate in shaping the future of our community.

NEW FISCAL YEAR

At the September Board Meeting, the LICIA Board approved changing the Association's fiscal year to January through December. Since LICIA's inception in 1959, the fiscal year was November through October, which frequently caused confusion about dues paid in the last few months of the year. Now it's nice and simple: dues paid during the calendar year apply for that entire year. The Board also approved that any dues paid from August thru December of 2024 will be applied to 2025 calendar year. LICIA dues at \$20 are a bargain, too. Other associations charge \$30 and in a couple of cases \$50 per year.

Riverland Road (Speedway) Traffic Calming Update

We asked for it, and it's finally happening. The design for the traffic calming improvements along Riverland Road has been completed by the City's consultant, Kimley-Horn and Associates, and approved by Broward County. The Construction Plans & Specifications are expected to go out for bid in March 2025.

Once a contractor is selected, a detailed construction schedule will be developed. This project was funded in the City's FY 2025 - FY 2029 Adopted Community Investment Plan (CIP).

Planned traffic calming enhancements include:

- Raised intersections at SW 35th Avenue, Riverland Terrace, SW 27th Avenue, SW 21st Street, and SW 19th Street
- Raised crosswalks on Riverland Road, east of Tortugas Lane and Bimini Lane
- A median refuge island at the existing crosswalk near the driveway at 3901 Riverland Road

Stay tuned for updates as we move forward with this important safety improvement project!

ACTION IN THE ISLES – The Boat Ramp

From the FWC Division of Law Enforcement Weekly Report, Feb 7 - 13

"Officers Bovee and Comartin responded by patrol vessel to the vicinity of the Riverland boat ramp and the New River in reference to a dead manatee. They arrived and found an approximately 6foot-long dead manatee in the river. They took the manatee to the local boat ramp. An FWC biologist took possession of it and will be performing a necropsy." (*No further info was available at press time*)



The owner of this barge decided to tie up to the west dock at the boat ramp for a week in January. Code Compliance was finally able to "urge" him along. LICIA is working with Commissioner Sorensen and the City to create regulations preventing this in the future.



Living with Coyotes in Lauderdale Isles



Coyotes are interesting animals that inhabit many areas across the United States, including our own Lauderdale Isles community in Florida. The most recent sighting was reported by Florida Fish and Wildlife on October 9, 2023. In conversations

I've had with some neighbors, they mentioned that these creatures are being spotted more frequently than what is recorded. The map below indicates sightings/incidents within 2 years and over 2 years ago.




As more coyotes start to appear around our area, it's important to know how to live alongside them safely so that both people and coyotes can stay out of trouble. In this article, we'll learn about what coyotes are, why they matter, and some easy tips to help us live peacefully together.

What Are Coyotes? Coyotes, part of the dog family and known for their thin bodies, pointy ears, and fluffy tails, play a crucial role in controlling the populations of smaller animals like mice and rabbits, thus maintaining environmental balance. As human populations grow in areas like Lauderdale Isles, coyotes are increasingly encroaching on neighborhoods, leading to potential conflicts.

Why Do Coyotes Come to Our Community? Coyotes often enter neighborhoods in search of food and shelter, which can concern pet owners due to their potential scavenging habits & interest in small pets. They generally prefer to avoid contact with humans

Despite what you may read about water quality in other parts of Fort Lauderdale, the waters of Lauderdale Isles are in good shape and as a result, there are a lot of these snook around now. Sheepshead are plentiful around dock pilings. Lots of fun catching blue crabs, too. Is this a great neighborhood or what????

Snook season in our area runs until June 1. Bag limit is one per day, slot size is 28" - 32".

Cobia Canal This 39 foot boat sank on June 29, 2024. At the Special Magistrate hearing on Jan 14, 2025, the Magistrate imposed a fine of \$2500 for



"sunken vessel causing a fuel spill." It was also cited for being a "derelict vessel."

Turtle Canal This vessel sank Oct. 9, 2024. At the Special Magistrate hearing on Dec. 12, 2024, the Magistrate



imposed a fine of \$15,000 for "sunken vessel that has spilled fuel." Also cited for "illegal dock rental" and "derelict vessel."

MEET OUR NEW CODE COMPLIANCE OFFICER

Matthew Flesher has been our Code Compliance Officer for about six months. He was previously with Miami

Beach as a Code Compliance Officer for about a year. He is originally from Michigan, Detroit metro area and attended Central Michigan University and graduated with a teaching degree. He spent five years teaching English language in Japan and then taught at Hollywood Hills Elementary for six years. He then become a Code Compliance Officer after completing his training and testing with the

city's Department of Sustainable Development.

I recently had the pleasure of sitting down with Mr. Flesher as he shared some beneficial and important information that I know will be advantageous for us all. He guided me with direction on how to navigate through the municipality's websites that I am honored to share with you. If, for example, you are interested in finding a code applicable to a particular situation you would go to the website at library.municode.com (Library | Municode Library) to locate the code of ordinances. A map will appear, then click on Florida, then select

Fort Lauderdale. You can scroll through the listing or use the search field to narrow down your enquiry. You will also find on the left side bar the unified land development codes.

The website for researching permits, code cases and violations is best found by Googling LauderBuild which will direct you to this website <u>https://aca-prod.accela.com/FTL/Default.aspx</u> - also viewed as <u>Fort Lauderdale Portal</u>. You can then hover over the <u>Search</u> dropdown and click on <u>Community and Compliance</u> which will take you to a record search. Not all fields are required, you can select the fields that you are aware of that will provide your results. There you will find more information in the drop downs that are offered that will provide more information and details on your search.

Common Violations that are found by our Officers are related to exterior building structure (house upkeep, fascia's, paint, etc.), driveway maintenance, vehicle parking, motorcycles, watercraft, trailers of any type must be parked on a legal driveway or garage, yard maintenance and outdoor storage of junk, trash and debris, etc.

Fort Lauderdale offers a website that is available in a downloadable app or Google Play – <u>fortlauderdale.gov/FixItFTL</u> that makes it easy for residents to not only report code compliance issues but also matters such as road kill, cracked sidewalks, pot holes, street-light outages, graffiti, clogged storm drains and more. By utilizing these tools described, together we can help to keep our charming community neater, pleasant and appealing.

After being off the water for routine maintenance, the Code Compliance boat is back in service as of January 27th.

As a closing note Matthew reminds us of the residential refuse collections rules of placing trash bins on the edge of the roadside; 2 feet apart and 2 feet from any mail boxes (light posts, trees, etc.) and 2 feet from any vehicles.

Please note that Matthew is not the Compliance Officer for Vacation Rentals, refer any questions and inquires of these matters to Officer Evan Oaks (EOaks@fortlauderdale.gov).

Matthew covers some of both District 3 and 4 from 441 east and south of Davie with Middle River on the south end and some of District 4 to I-95 on the east (southern edge). The Native New River

"I remember when there was nothing here." "I remember when there was a rope swing there." "I remember when this was Aquaglades Park."

These reflections from Fort Lauderdale residents resonate with me, as I cherish hearing their memories. Researching the history of the New River, particularly southwest of the current Coontie Hatchee Park and the Davie Blvd Bridge, reveals fascinating stories from past generations of Florida residents. Stay tuned for more on

that. But what existed before Fort Lauderdale pioneer Frank Stranahan arrived?

According to a Miami Herald article from October 9, 1955, "Historical




Historic picture of the New River

accounts, dating back before the time white men came to this area, show that the New River was once known as Coontie Hatchee. Coontie is a starchy substance used in bread made by Indian women, now known as arrowroot, and is often prescribed by doctors for infants and invalids. Historians claim that the Fort Lauderdale area was a great Coontie region, hence the river's name, Coontie Hatchee. Hatchee is the Indian term for river. Coontie refers to several tropical American woody plants whose roots and stems yield starch."

Patricia Burghard's 1947 manuscript, "The History of Fort Lauderdale," paints a vivid picture of the landscape: "Before the hands of civilization took hold, it flowed through wild, tropical jungles and dense pine forests. Leaves of the graceful palm dipped over the water's edge, creating reflections of beautiful tropical birds flying overhead.

Great ferns danced gently upon its banks, while strangler fig and water oak stood guard beside it."

A little more about Coontie. I planted Coontie in my yard because it is native. Although they were pricy at \$30 for a 3-gallon pot, they have been easy to maintain. Coontie is the only cycad native to the United States. It's also the preferred food source for larvae of the rare Atala butterfly. The Coontie (Zamia integrifolia) looks like a small fern and is typically one to three feet tall. It has



stem. Florida's native peoples once ground up these underground stems to create a starchy "flour" for cooking. Don't try this yourself, though—the stem is toxic unless prepared properly. Because of its high drought tolerance and moderate salt tolerance, the Coontie is an excellent choice for the coastal landscape. And it's cold hardy, too. Coonties can be planted in sun or shade.
