



**Homestead Housing Authority  
Housing Choice Voucher/Section 8 Program Waiting List**

**Homestead Housing Authority (HHA) will be accepting preliminary applications for the Section 8/Housing Choice Voucher Waitlist online beginning on August 28<sup>th</sup>, 2023 at 8:00AM. The application will be closed on Friday, September 1<sup>st</sup>, 2023 at 5:00 PM.** To be eligible to be placed on the waiting list, the Head of the Household MUST be 18 years of age or older. Applications must meet all U.S Department of Housing and Urban Development (HUD) income and eligibility requirements. The total household annual gross income must not exceed the very-low income limits for the appropriate family size as listed in the Income Limits Table appearing at the end of this Public Notice.

**Preliminary applications must be completed online.** If you wish to apply you will need to login to the following website [www.homesteadfl.housingmanager.com](http://www.homesteadfl.housingmanager.com). Please ensure that you complete all the required fields of the application or it will not be successfully submitted at the end. If your application is successfully submitted you will receive a receipt confirming the submission. **Note: Homestead Housing Authority will not have any applications for distribution.**

**APPLICANT SELECTION:**

HHA will conduct a random lottery of all eligible applications to fill 2500 positions on the 2023 HHA Section 8/Housing Choice Voucher waitlist. The time and date of application submission has no bearing on the position of applicants on the waitlist. There is no advantage to applying immediately after the list opens.

**If you or anyone in your family is a person with disabilities, and you require a reasonable accommodation with assistance in the completion of the application, please contact Blanca Ortiz at 305-247-0639. Please do not call the office for updates; you will be notified in writing if you made it in the lottery. Only families selected will receive notice by September 30<sup>th</sup>, 2023.**
