

# DEALERS...DEALERS...DEALERS!

The application to reserve dealer tables for the **2026** California State Button Show is below.

1. **Membership Requirement:** Dealer must be a current (2026) CSBS member in good standing (membership dues should be paid in advance of Dealer application).

2. **Dealer Acceptance:**

- a. Dealers will be accepted in sequence of receipt of the application.
- b. If dealer applications come in after most tables have been assigned and there are more of these late applicants than tables, the following criteria may be applied. *First* will be those dealers who have supported CSBS with their time as volunteers (clerks, judges, runners, rack set-up or tear-down, etc.). *Second*, by past dealer participation.
- c. **All dealers who have applied will be notified by April 7th** as to their status as having tables or being put on a waiting list. Dealers will be placed on the wait list in sequence based on their application postmark date. If there are cancellations, they will be accommodated in that sequence.

3. **Dealer Table Fees:** Each table is \$50. Total payment is required with each application. Cancellations within two weeks of the show will be assessed at a \$10 *per table* penalty fee.

4. **Mailing Requirements:** Application and deposit must be postmarked **no later than March 15** of the Show year. Applications must be mailed. No reservations will be accepted via e-mail or a phone call.

Should I/we cancel two weeks or less in advance of the show, I/we can expect to pay a \$10 *per table* penalty fee. I understand that, if I am unable to attend, I cannot assign my table to someone else. By signing and dating this form, I/we agree to all terms as stated above.
