**RESOLUTION NO.: SL - 52 - 2024**

**TITLE: APPROVAL OF MOU WITH THE ARTEMISIA  
ARCHAEOLOGICAL RESEARCH FUND (AARF), UNIVERSITY OF  
NEVADA, RENO**

**WHEREAS**, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

**WHEREAS**, the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and

**WHEREAS**, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and

**WHEREAS**, the Summit Lake Paiute Council has been organized to represent, develop, protect, and advance the views, interest, education, resources, and general welfare of the Summit Lake Paiute Tribe (SLPT) membership; and

**WHEREAS**, the SLPT wishes to enter into a Memorandum of Understanding (MOU) with the Artemisia Archaeological Research Fund (AARF), University of Nevada, Reno; and

**WHEREAS**, the objective of the MOU is to establish a framework of cooperation between the SLPT and the AARF respecting the management of information pertaining to cultural resources and traditional knowledge, including data collection, data standards, and data sharing related to archaeological and paleoenvironmental research, collected through future work with the Last Supper Cave collection; and

**NOW THEREFORE BE IT RESOLVED** that the Summit Lake Paiute Council hereby approves to enter into the MOU with the Artemisia Archaeological Research Fund (AARF), University of Nevada, Reno; and

**BE IT FURTHER RESOLVED** that the Summit Lake Paiute Council does not waive, alter, or otherwise diminish its Sovereign Immunity, whether expressed or implied, by virtue of this grant contract for any and all administrative or legal action which may arise directly or indirectly from the same. Furthermore, the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute any instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
